One side of the structure has been covered with stucco and vertical metal siding. There are no landscape plantings on the loading side of the building.

Building #03448 has been change substantially since its construction in 1944. In addition to the blocking up of windows and doors, replacement of sash and the addition of new doors, and replacement of roofing materials, one side of this structure has been encapsulated with a new stucco and vertical metal siding facade. This action has completely covered the original construction and changed the building character to one of a contemporary storage building, rather than a 1940's storage building.



