These buildings are all one-story tall, concrete block structures built in 1943 on the east side of the base. The buildings were all constructed as barracks for base personnel. They are complex "E" shaped plan, with entries at points along their long sides and ends. Each building has a moderate-sloped, asphalt shingle, gable roof. Between 1958 and 1961 the buildings were covered with aluminium siding. They have all been converted to office space. Interior spaces have been modified significantly to accommodate new uses. The original windows, doors, and roofs have been replaced.

The Building #03462 series of structures were, for the most part, all constructed as temporary barracks. As more permanent housing was developed on the base these buildings were converted to various other uses. At this point they are used as administrative offices. All have been significantly modified through reconfiguration of interior spaces to accommodate new uses, replacement of windows and doors, new roofs, the introduction of air conditioning systems, and the covering of the original concrete block exteriors with aluminium siding. Due to these changes, the integrity of the original design and architecture has been lost.


