An addition has been placed at the back of the structure. The original building has been encased within a new brick shell. All original windows and doors have been removed, as well as interior partitioning and fixtures. A new entry has been placed at the front of the structure.

Building #03710 now serves as the base engineering office. It is a T shaped plan, originally built of concrete block. The building has undergone numerous changes over the years, the latest being completed in 1995. All of these have resulted in a total loss of the building's integrity of design, setting, and use. The exterior of the structure has been covered in brick, the original windows have been replaced with tinted fixed glass units, a new roof has been installed, a new entry has been placed on the building, and the interior floor plan has been modified to meet the new use.



