<p>The building is a small, A-roofed structure with a low-pitched, gabled facade. The central doorway has a square window above. Flanking it are two semi-circular windows set in semi-octagonal surrounds. The sidewalls have three similar windows, and there is one in the chancel end. On the southwest corner there is a tower with a two story elevation; the first story is a window and the second a louvered panel (made from a shutter leaf). The tower has an octagonal roof. The entire building is sheathed with tongue-and-groove siding.</p>
