DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The building is a large, 2-1/2 story frame warehouse with a one-story porch running across the north gable end. The porch has square, chamfered posts and arched braces from the post to the soffit of the cornice. The facade is six bays wide; in the gable are two square-headed windows about 1/3 of the distance of the ridge and a large semi-circular vent near the ridge. Near the center of the roof, there is a rectangular skylight with glazed lights and a low-pitched roof. Under the building is a full brick-walled cellar.

D. GIBBONS HALL PG:79-24

Gibbons Hall was a large nineteenth century frame structure which stood until recently in the middle of the island formed by present-day Main and Pratt Streets. It was constructed in all likelihood by Edward Grafton W. Hall, an Upper Marlborough merchant, sometime between 1861 and 1878 and was used by him as a warehouse. In later years the building was utilized as a school by St. Mary's Catholic Church and was named for Cardinal Gibbons.

E. THE MARLBOROUGH ACADEMY

The Marlborough Academy was established by law in 1836 for both sexes, and separate school buildings for boys and girls were constructed at about that time. The last remnants of the Academy were destroyed around the turn-of-the-century.

F. THE BALL ROOM OR ASSEMBLY ROOM

The Ball Room or Assembly Room, as it also was called, was constructed on the east side of present day Elm Street probably during the 1740's or 50's. It served the town of Upper Marlborough as a facility for balls, concerts, and theatrical productions until sometime between 1830 and 1850. It also disappeared near the turn-of-the-century.

G. THE RIDGLEY HOUSE


The Ridgley House, which until recently stood on the east-west leg of today's Elm Street, is so called because a Charles Ridgely appears as its owner on an 1878 map of Upper Marlborough. Similarly an 1861 map of the town shows a Mrs. Young as owning the building. This frame structure is believed to have dated from the late eighteenth century and was the most recent of the buildings to be moved by Perry Van Vleck from Upper Marlborough to Lower Marlborough in Calvert County.

H. THE OLD MILL

The site of the Old Mill of Upper Marlborough is located not far from the northwest edge of Schoolhouse Pond. A mill or mills have occupied this site since the very beginnings of the town of Upper Marlborough and possibly even before that time. In the 1720's Daniel Carroll, father of Bishop John Carroll and Daniel Carroll of Rock Creek, operated a grist mill in this location. Milling operations on the site continued into the twentieth century and the last mill structure










Tax Map 101, P. 168
