

Description:

This 1 1/2-story, side gable, brick, "cape-style" house contains neo-classical elements with five course American bond and brick "soldier" lintels, black shutters, and two dormers with vinyl siding. Other features include a decorative water table course, 6/6 windows, an intersecting "L" addition, a rear chimney, and a wood front porch. Overall, the structures offers a symmetrical appearance. It was constructed in 1947.

National Register Evaluation:

Research has not revealed any association between this structure and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in the past (Criterion B). The building is not a good example of any style; nor is it distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). Although archeology was not addressed in this study, there is not indication that the property is likely to yield information important in history or pre-history (Criterion D). Therefore, this
