

Description:

The residence at 511 Kerby Hill Road consists of a side-gabled, single story structure with asbestos shingle siding, a concrete block foundation, and asphalt roofing shingles. A room size addition was added to the side of the structure. A gable front pediment projects over the main entry.

National Register Evaluation:

Research has not revealed any association between this structure and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in the past (Criterion B). The building is not a good example of any style; nor is it distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). Although archeology was not addressed in this study, there is not indication that the property is likely to yield information important in history or pre-history (Criterion D). Therefore, this property is not National Register-eligible.


