Description:

The residence at 512 Kerby Hill Road consists of a side-gabled, single story structure of brick construction, with asphalt roof shingles and 8/8 windows. A porch extends across half of the main façade.

National Register Evaluation:

Research has not revealed any association between this structure and events that have made a significant contribution to the broad patterns of our history (Criterion A) or the lives of persons significant in the past (Criterion B). The building is not a good example of any style; nor is it distinguished; it does not represent the work of a master or display high artistic merit (Criterion C). Although archeology was not addressed in this study, there is not indication that the property is likely to yield information important in history or pre-history (Criterion D). Therefore, this property is not National Register-eligible.


