Description:

The Gardiner house is set on a town lot, facing Juliette Drive to the north. It is a large two-and-one-half-story hipped roof frame structure, square in plan. It has a narrow cornice, wide overhanging eaves, an asphalt shingled roof, horizontal siding, and a cement foundation. The 5 bay north (main) facade has a central cross gable with a six light double casement window. On the first story is a central entrance with a modern door, flanked by 10 light side lights with plain wood surround and crown molded cornice. The entrance is set in a projecting bay with a one-bay entrance portico with a pedimented gable roof on two tapering, smooth wooden columns with Doric capitals and a round arch opening over the entrance. The first floor windows are 8/1, with louvered shutters, a wood sill and lintel with crown molding. The west facade has a two-story enclosed porch with a flat roof, and an exterior, high corbelled brick chimney. The 6 bay south (rear) facade has a central cross gable with a six light double casement window. The west facade has a high interior corbelled brick chimney on the west slope of the roof. There is a gable roof, one-story shed immediately south of the house, and no other outbuildings on the tree-shaded lot.

Significance:

The Gardiner house is a large Georgian Revival house built ca. 1922 by James and Catherine Gardiner, who moved to the Clinton area from the midwest. The house stood on 209 3/4 acres at the time of its construction and was a part of a working farm. James St. Clair Gardiner became active in the Clinton community, serving on the Board of Directors of the Clinton Bank. The farm was subdivided in 1956, by John M. and Elizabeth Pryde, later owners of the property. The Gardiner house now stands on a 1.18 acre lot in the Surratts Gardens subdivision, surrounded by other housing. It is distinguished by its large size and Georgian Revival details, as well as by attractive plantings in its surrounding yard.

The Gardiner house is situated on a town lot, facing Juliette Drive to the north. It is a large two-and-one-half-story hipped roof frame structure, square in plan. The house is sided with weatherboard and rests on a cement foundation.

The five bay north (main) facade has a central pedimented cross gable with a six-light double casement window, set behind the roofline. On the second story, two central small six-light casement windows are flanked by two 8/1 double hung sash windows on each side. On the first story, the central entrance has a modern door, flanked by ten-light side lights, and having a plain wood surround and crown molded cornice. The entrance is set in a projecting bay sheltered by a one-bay entrance portico with a pedimented gable roof supported on two tapering, smooth wooden columns with Doric capitals. The pediment has a crown molded raking cornice and a round arch opening over the entrance. The four first story windows flanking the entrance are 8/1. All have louvered shutters, a wood sill and lintel with crown molding.

The west facade has a two-story enclosed porch with a flat roof. There is a high corbelled brick chimney enclosed by the porch but exterior to the main block. The porch is covered with rough horizontal siding and has a central double entrance with a transom. A wide horizontal band of windows on the first and second floors approximates four bays.

The six bay south (rear) facade has a central pedimented cross gable with a six-light double casement window. On the southeast corner of the facade is a shed roof, 2 bay, one-story enclosed screened porch with an entrance. There are two foundation windows centered on the facade.

The east facade has a high interior corbelled brick chimney on the west slope of the roof. There are three, unevenly spaced upper bays, and four lower bays. There are four foundation windows evenly spaced across the facade.

There is a gable roof, one-story shed to the immediate south of the house. There are no other outbuildings on the tree-shaded lot.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large, frame, Classical Revival house that sits in the middle of the Surratt Gardens Subdivision. The main (north) facade consists of five bays, with a central door. The door has side-lights, and is framed by an open, pedimented portico that features an arched ceiling. The steep hip-roof has a small center gable in this facade. Siding is clapboard. There are several additions to the east and rear. The large old chimney stacks indicate this may be a remodelling of an earlier building.
