Description

The Burroughs tobacco barn stands immediately north of Croom Airport Road, just a few yards from the actual right-of-way. It has a steeply pitched gable roof and deep side wings. Its roof ridge runs roughly east and west, and slopes to low side wings on both of the long north and south sides. The barn is sided with wide vertical boards, all circular sawn. It rests on heavy hand-hewn sills; all interior posts and rafters are circular sawn. The roof is of corrugated metal. There is a small door in the south side, and a larger door in the west gable end. Immediately west of the barn is a small gable-roofed outbuilding.

Significance

The Burroughs tobacco barn is typical of the late nineteenth century tobacco barns which once dotted the landscape of Prince George's County. It stands on a tract known as Brookridge which was farmed for most of the nineteenth century by the Burroughs family. The home place of Richard W. Burroughs was a short distance southwest of the present barn; after his death in 1870 the farm passed to his son John W. Burroughs, and it was probably in the period following that this barn was constructed. During this period the road from Croom to Selby's Landing on the Patuxent ran to the north of the barn, acting as a boundary between the Burroughs' land and that of their neighbors to the north, the Duley, Pumphrey, and Early families. In the twentieth century the road was relocated to the south, following the line of an old farm lane; the present day road lies south of the barn, cutting it off from the larger part of the Burroughs property and creating a separate small parcel of land. Today the Burroughs barn stands directly on the north edge of the road, still in use, a prominent symbol of the tobacco economy in nineteenth century Prince George's County.

### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an old, frame tobacco barn that sits right on the road, at a bend near Duvall Road. It has an unusual, wing-shaped form, as a result of the tall, A-roofed center section. This section fans out several feet below the ridge to form sloping, shed-roof wings. A small door is in the west gable facade. The main poles are hewn, and there are several, hinged siding boards that open for drying.
