Description:

The Burns Wilson House is a one-and-one-half story bungalow, square in plan, three-by-four bays, situated in a cluster of trees just northeast of the Burns Wilson Shop building. The four bay south facade has entrance in the first and fourth bays through 5-panel doors. Windows are 2/2 sash with wood surrounds and sills. The screened entrance porch is sheltered by the roofslope of the main block. The roof rests on square posts with capital and base molding and corner boards. A shed roof dormer is centered above the entrance facade. The house is of poured cement construction, the roof covered with asphalt shingle. The eaves have a deep overhang. Foundation windows are visible on the gable ends. The north (rear) facade is dominated by a two-by-one bay, hipped roof cement block addition. The interior of the house has a four-room square plan. The two entrances enter the kitchen and dining room. The northeast room contains a stair to the second floor. Door and window surrounds are walnut, of plain board with corner blocks. A crown molded picture rail circles each room. There are many and varied mature trees surrounding the house including cypress trees, blue spruces, a cedar, two scotch pines and English boxwood.

Significance:

The Burns Wilson House and Shop are significant for their vernacular architecture and for their connection with their builder, David Burns Wilson (1890-1973), well known in the southeastern county area as a handy man. Wilson acquired one acre of property in Naylor from Maria A. Duvall in 1920. He seemed to have a genius for making and repairing things. Before he married, he had worked out of a shop on his family's homestead (P.G. #87A-27). He built the shop building and his house in Naylor shortly after 1920. The shop is of lumber from the Wilson farm on Mill Town Landing Road, sawed in the sawmill there. In style it is a simple, functional building with no architectural embellishments. It presently is unused and deteriorating. The house, a small bungalow constructed of poured concrete, has walnut interior wood work made by Wilson. It is also simple in plan and construction materials, and is presently inhabited by two of Wilson's children.

The Burns Wilson House is a one-and-one-half story bungalow, square in plan, three-by-four bays, of poured cement construction. It is situated in a cluster of trees just northeast of the Brookfield Methodist Church, and the Burns Wilson Shop building.

The four bay south (main) facade has entrance in the first and fourth bays through 5-panel doors. Windows are 2/2 double-hung-sash with wood surrounds and sills. The four-bay screened entrance porch is sheltered by the extended roofslope of the main block. The porch roof rests on square posts with capital and base molding and corner boards. The porch is supported on cement piers interspaced with wood lattice. A shed roof dormer with a double three-light casement window is centered above the entrance facade. A brick chimney rises from the north corner of the dormer.

The house is of poured cement construction, built up in horizontal layers. The upper gable ends are covered with blue asphalt shingle, the roof covered with grey asphalt shingle. The eaves have a deep overhang. Foundation windows are visible on the east and west gable ends. The north (rear) facade is dominated by a two-by-one bay, hipped roof cement block addition with a north end exterior brick chimney.

The interior of the Burns Wilson House has a four-room square plan. The two south entrances enter the kitchen and a dining room. The northeast room contains a stair to the second floor. Door and window surrounds are walnut, of plain board with corner blocks. A crown molded picture rail circles each room. The walls are of plaster over cement, the plaster has sustained much damage from moisture.

There are many and varied mature trees surrounding the house. Four tall cypress trees were planted, one for each of Burns Wilson's children. There are also blue spruces, a cedar, two scotch pines and overgrown English boxwood.

The Burns Wilson House and Shop are significant for their vernacular architecture and for their connection with their builder, David Burns Wilson (1890-1973). Wilson was well known in the southeastern county area as a fix-it and handy man.

Because his wife was from Naylor, Wilson acquired one acre of property in Naylor from Maria A. Duvall in 1920.¹ Wilson made a living repairing cars, blacksmithing, wood and metal working. He seemed to have a genius for making and repairing things.² Before he married, he had worked out of a shop on his family's homestead on Mill Town Landing Road (P.G. #87A-27). He built the shop building and his house in Naylor with the assistance of his father and brother, shortly after 1920. The shop is of lumber from the Wilson farm on Mill Town Landing Road, sawed in the sawmill on that property.³ It is furnished with built-in drawers and shelving Wilson made to hold tools and parts. In style it is a simple, functional building with no architectural embellishments. It presently is unused and in deteriorating condition.

The Wilson house, a small bungalow constructed of layers of poured concrete, has walnut interior wood work made by Wilson. The house is also simple in plan and construction materials. It is presently owned and inhabited by two of Wilson's children.




