The house is a 1-1/2 story log structure with a three-bay main (north) facade with a central shed-roofed dormer. The logs are square hewn and joined with half laps; the chinking is pine poles covered with plaster. The entire facade is white-washed. The chimney is internal at the east end.

An A-roofed addition extends to the east and a lean-to has been added on the south. An A-roofed porch covers the main facade.


