DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The house is a 1-1/2 story, frame structure with a six bay main (south) facade. At the east end, a lower frame wing runs at right angles to the main house.

The facade is composed of two sections, each with a central doorway and flanking windows. The second floor windows are 3/3 double hung sash. At the west end is an external chimney with a 1-1/2 story base and free standing stack. The rear (north) facade has irregular fenestration with 3/3 double hung sash except for one 6/6 double hung sash window on the ground floor at the west end of the facade.


