Description:

The Dr. Edgar D. Hurtt house is a two-part frame gable-roofed dwelling which stands on a lot on the north side of the main road through the town of Piscataway; it consists of a two-and-one-half-story main block with a one-and-one-half-story kitchen wing attached at its west gable end. The main block is three bays by two bays, with entrance in the central bay of the three-bay south facade. The entrance bay is sheltered by a one-story porch with ornamental brackets, balusters and benches. The main block is covered with German siding and has a wooden watertable. Windows are 1/1 with plain board surrounds; there is a shed roofed dormer centered in the south plane of the roof over the entrance. There are two chimneys, a rebuilt interior-brick chimney at the ridge at the east gable end, and a (parged) exterior brick stack located south of the ridge at the west gable end, now enclosed by the kitchen wing. The one-and-one-half-story kitchen wing is two bays by one bay with entrance in the west gable end. It is covered with random-width, beaded weatherboard siding. Windows are narrow 4/4 sashes with narrow board surrounds. The entire house rests on brick piers reinforced with concrete. The metal roof is covered with asphalt shingles.

Significance:

The Hurtt house was the home and office for 60 years of Dr. Edgar Dewitt Hurtt. Dr. Hurtt graduated from the University of Maryland School of Medicine in Baltimore in 1854 and in that year began to practice medicine in the village of Piscataway. In 1857 he purchased from the Parker family this two-part house on Piscataway's main street, and for sixty years raised his large family and practiced medicine there. The west wing was used both as kitchen and surgery. In 1870 Dr. Hurtt was appointed surgeon to the Maryland National Guard, and assisted as surgeon at Fort Washington. At the time of his death in 1917 at the age of 87, he was reported to be the oldest practicing physician in Maryland. Construction details suggest that the first story of the main block of Dr. Hurtt's house dates from the eighteenth century; the kitchen wing was added during the first half of the nineteenth century. In 1912 Dr. Hurtt had the main block raised to its present full two-and-one-half stories. Restoration work was undertaken by the present owners, descendants of Dr. Hurtt, in the early 1980's. The house is significant in that it represents three centuries of consecutive construction. It is a local landmark as the house and office of one of Piscataway's best-known citizens. It is now a handsome and comfortable dwelling in what remains of the once-thriving commercial town of Piscataway.

The Dr. Edgar D. Hurtt house is a two-part frame gable-roofed dwelling which stands on a lot on the north side of Floral Park Road, the main road through the town of Piscataway. The house faces south toward the road, and consists of a two-and-one-half-story main block with a one-and-one-half-story kitchen wing attached at its west gable end.

The main block is three bays by two bays (ca. 37 by 23 feet), with entrance in the central bay of the three-bay main south facade. The entrance bay is sheltered by a one-story flat-roofed porch with ornamental (wooden) brackets, balusters and benches. The interior plan is composed of a central stairhall with two rooms on each side, the southerly being larger than the northerly; the two south parlors have plain wooden mantels. The main block is covered with German siding painted beige and has a wooden watertable. Windows are 1/1 with plain board surrounds; there is a shed roofed dormer centered in the south plane of the roof over the entrance. There are two chimneys, a rebuilt interior-brick chimney at the ridge at the east gable end, and a (parged) exterior brick stack located south of the ridge at the west gable end, now enclosed by the kitchen wing. Floor joists are heavy hand-hewn timbers with peg holes on top, indicating reuse.

The one-and-one-half-story kitchen wing is two bays by one bay (ca. 20 by 15 feet) with entrance in the center of the west gable end. The wing consists of one large kitchen room, with a loft over it, reached by a boxed staircase in the southwest corner. In the loft, pegged half-lapped rafter joints are visible, as well as wide circular-sawn roof decking boards. The kitchen wing is covered with random-width, beaded weatherboard siding. Windows are narrow 4/4 sashes with narrow board surrounds. The heavy timber framing of the wing is reportedly filled with brick nogging.

The entire two-part house rests on brick piers reinforced with concrete. The metal roof is covered with asphalt shingles.

A photograph in the possession of the owners shows the house before 1912. The main block was then one-and-one-half stories high, with a slightly higher roofline than the kitchen wing. In 1912 the main block was raised to two-and one-half stories, and the Victorian porch was retained.

To the west of the house stands a twentieth century frame garage structure. The smoke house which stood north of the house was destroyed in recent years. The lot formerly contained also a chicken house and barn. Behind the Hurtt lot, adjoining it on the north, is the St. Mary's Catholic Church property.


