Description:

The Wilson-Rawlings House is a large, gable roof, two-story frame structure set on a hillside south of Milltown Landing Road. The house is irregular in plan, with a brick foundation and German siding. The three bay north (entrance) facade is under the gable end, having two 1/1 windows with wood surrounds and louvered shutters on first and second stories, and a rectangular window with sidelights in the gable. The northwest bay is a two-story gable roofed stair tower. Entrance is in the tower's east side. The door has a dentiled, crown molded cornice. A brick at the stair tower east corner reads "1836" - "1895". An "L" shaped porch on the northeast bays of the facade continues for four bays across the east facade. It has a boxed cornice with dentils, and turned wood posts with jig-sawn fan brackets. The house has a crown molded, boxed cornice, a wide frieze and cornice returns in the gable ends. The four bay east facade has entrance in the second bay. The east facade overlooks the Patuxent River. A corbelled brick chimney is on the east slope of the roof. The west facade has a projecting two-by-two bay, two-story gable end with a high chimney at the gable peak. The four-bay south (rear) facade has a two bay porch with the same details as the entrance porch. There is a south facing gable end. There are six frame outbuildings south of the house, three with board and batten siding, four with wood shingle roofs. There is a Wilson family grave to the east of the house, down the hillside.


Significance:

The Wilson-Rawlings House is a large, handsome vernacular dwelling built in 1895 by Margaret Johns Wilson and family. It is significant for its vernacular architecture and its connection with the Wilson family. The Wilsons acquired the 80-acre property in 1882. The 1880 U.S. Census lists Wilson, aged 55, living with her planter sons. The extended family owned a great deal of property in the area. The house is sited on a hill overlooking the Patuxent River Valley. East of the house are two ca. 1900 Wilson farmhouses in view. The house is typical of vernacular dwellings built in the County in the late nineteenth century. It is unique for its two-story stair tower containing the main entrance, with a secondary entrance on the east (river) side.

The Wilson house and property remained in that family from 1882 until 1965.

SUBJECT: Staff Recommendations on Historic Site Designation
of P.G. #87A-19, the Wilson-Rawlings Farmstead

The Wilson-Rawlings House is a large, white frame farm dwelling, constructed in 1895, standing on a 92-acre parcel in rural southeastern Prince George's County. While presently undergoing remodeling of the south (rear) and west elevations, including the enclosure of the rear porch and involving cutting new window openings, the house and its setting, including outbuildings to the south, are eligible for historic site designation, based on the following criteria:

- 1c The farmstead is identified with the Wilson family, who had owned the surrounding property since the 18th century and built the house in 1895.
- 1d The farmstead exemplifies the cultural and economic heritage of the County's 19th century farming communities. The house and its outbuildings represent a continuum of the farmstead that had been on the site at least since 1835. It and the two early 20th century Wilson houses to the east, create a small family farm community that has existed since the late 19th century.
- 2a The farmstead exemplifies the distinctive characteristics of a late 19th century vernacular farm dwelling, with design elements from the mid-19th century in its decoration and floor plan, including a crown-molded returned cornice and dentils and brackets on the wrap-around entry porch, as well as a bracketed main stair.

The Wilson-Rawlings House is a large, gable roof, two-story frame structure set on a hillside just south of Milltown Landing Road. The house is irregular in plan, with a brick foundation and German siding. The house has a view of the Patuxent River, to the east.

The three bay north (entrance) facade is under the wide gable end. There are two 1/1 windows with plain wood surrounds and louvered shutters on the first story and two on the second. There is a rectangular window, and a crown molded, returned cornice. The main entrance to the house is in the tower's east side. The entrance has a dentiled and crown molded cornice. A brick in the foundation, at the east corner of the stair tower has two dates, "1836" below and "1895" above.

There is an "L" shaped porch on the northeast bays of the north facade, sheltering the entrance. The porch continues for four bays across the east facade. The porch roof has a boxed cornice with dentils and a wide frieze. The roof rests on turned wood posts with jig-sawn fan brackets. The building has a crown molded, boxed cornice with a wide frieze. There are cornice returns in all gable ends, including that of the stair tower.

The four bay east facade has entrance in the second bay. Windows are 1/1, also with louvered shutters. The east facade overlooks a valley with two Wilson family farmhouses, and the Patuxent River. There is a corbelled brick chimney on the east slope of the roof.

The west facade has a projecting two-by-two bay, two-story gable end with a high interior chimney at the west gable peak. The facade is unfenestrated except for a first story window south of center in the gable end.

The four-bay south (rear) facade has a hipped roof two bay porch on the projecting west gable. The porch has the same details as the north entrance porch, except that the posts are plain wood. There is a south facing gable end with two bays of windows on the first and second floors.

There are six frame outbuildings south of the house. These include a board and batten corn crib with a wood shingle gable roof, on brick piers; a board and batten chicken house with a corrugated metal shed roof; a board and batten garage with a wood shingle, gable roof; a small two story gable roof barn or stable with board and batten siding and a standing-seam metal roof; a large low German-sided shed roofed shed, probably under 50 years of age; and far south of the house a large two story board and batten barn with a gable roof-partially wood-shingled and partially covered with standing-seam metal. All seem to be in good to fair condition. There is a Wilson family grave, that of David B. Wilson, d. 1837, to the east of the house, down the hillside.

The Wilson-Rawlings House is a large, handsome vernacular dwelling built in 1895 by Margaret Johns Wilson and family. It is significant for its vernacular architecture and its long association with the Wilson family.

Margaret Johns Wilson acquired the 80-acre property, parts of tracts called Haddington, Dunbar, Good Luck and Tenant, in 1882.¹ The 1880 U.S. Census lists Wilson, aged 55, living with her planter sons, James Burns Wilson and William Walter Wilson.² The extended Wilson family owned a great deal of property in the area surrounding Milltown Landing Road, for many years.³ Although Wilson acquired the property from James and Susan Gibbons, it had been owned by the Wilson family in the 18th and early 19th century.⁴ It was sold to Clement R. Connick in 1855. The 60 year old brick house on the property, built by the Clement R. Connick, burned in 1895 and the present house was built by the Wilsons, on the same site.⁵ The Wilson-Rawlings House and property remained in Wilson family ownership from 1882 until 1945. The Rawlings, closely related to the Wilsons, owned the property from 1945-1965. The property was again purchased by Wilson family members in 1986. They presently are completing renovations on the house.

The Wilson-Rawlings House is attractively sited on a high hill overlooking the Patuxent River Valley. East of the house, there are two early 20th century Wilson farmhouses in view, in the river valley. The Wilson-Rawlings house is typical of vernacular dwelling built in the County in the late nineteenth century. Characteristics it shares with houses built during the period include its gable roof, two-story frame structure and its facade-wide entrance porch with jig-sawn brackets and dentilled frieze. The house is unique for its two-story stair tower containing the main entrance. There is a secondary entrance on the east (river side) facade.

The three bay north (entrance) facade is under the wide gable end. There are two 1/1 windows with plain wood surrounds and louvered shutters on the first story and two on the second. There is a rectangular window with sidelights in the gable peak. The northwest bay is a projecting, two-story gable roofed stair tower with a first and second story window, and a crown molded, returned cornice. The main entrance to the house is in the tower's east side. The entrance has a dentiled and crown molded cornice. A brick in the foundation, at the east corner of the stair tower has two dates, "1836" below and "1895" above.

There is an "L" shaped porch on the northeast bays of the north facade, sheltering the entrance. The porch continues for four bays across the east facade. The porch roof has a boxed cornice with dentils and a wide frieze. The roof rests on turned wood posts with jig-sawn fan brackets. The building has a crown molded, boxed cornice with a wide frieze. There are cornice returns in all gable ends, including that of the stair tower.

The four bay east facade has entrance in the second bay. Windows are 1/1, also with louvered shutters. The east facade overlooks a valley with two Wilson family farmhouses, and the Patuxent River. There is a corbelled brick chimney on the east slope of the roof.

The west facade has a projecting two-by-two bay, two-story gable end with a high interior chimney at the west gable peak. The facade is unfenestrated except for a first story window south of center in the gable end.

The four-bay south (rear) facade has a hipped roof two bay porch on the projecting west gable. The porch has the same details as the north entrance porch, except that the posts are plain wood. There is a south facing gable end with two bays of windows on the first and second floors.

There are six small frame outbuildings south of the house. These include a corn crib with a shed roof, on brick piers; a chicken house with a shed roof, two stables and a well with pump. Three of the outbuildings have board and batten siding. Four have wood shingle roofs. All seem to be in good to fair condition. There is a Wilson family grave to the east of the house, down the hillside.




