This is a two-story, rectangular, frame building with a two-story shed roof addition on the south and a one-story garage on the north. It has "stick-style" trim in the gable end and 2/2 windows. There are double doors in the main (east gable end) facade, and they have a transom-light. The building is now covered with asbestos shingles. It appears to have been a turn-of-the-century country store.





