Description:

The Orme Store is a multi-family dwelling located at the corner of Orme and Aquasco Roads. It is a two-story frame gable roof structure with a "T" shaped plan. The foundation is cement. The original wood siding has been covered with stucco. The roof is of standing-seam metal. The three bay east facade faces Aquasco Road. The central entrance is flanked by two 6/6 windows on the first and two on the second story. The windows have narrow wood molding, wood sills and wood shutters. There are boxed, overhanging eaves. The north facade has five bays with a gable end over the first bay. There is horizontal, brown painted siding in the gable peak, and a returned cornice. There is a second story door reached by an metal stairway. Windows have been altered. The west (rear) facade has a two-story shed roof addition on the rear gable end of the main structure. The upper gable has the same horizontal siding as the north gable. The five bay south facade has a first bay entrance. The fifth bay is beneath a gable end with horizontal siding in the upper gable. There is a corbelled brick chimney on the west slope of the roof. There is a cement island which was used for gas pumps, in front of the building. To the east and north sides of the building the yard is a paved parking lot. There is a one-story frame gable roofed garage to the northwest of the building. There is an island which was used for gas pumps, in front of the building. To the east and north is a paved parking lot.

Significance:

The Orme Store, south of Horsehead, must have been a well-known location for local residents. Emory Memorial Chapel and a school house were once near site. The store is on two acres called Orme. George E. Orme (1826-1894) owned a great deal of property in the area during the late-nineteenth century. Orme is listed on the 1870 U.S. Census as a Justice of Peace. The building does not appear on the 1878 Hopkins Atlas. The two acre property was transferred from the Orme family to John B. Dale, a close relative, in 1900. It is known that Dale kept a store on the site after 1900. The property was owned by the Dales through 1925, and has had a series of owners since. The building has been altered for use as a multi-family dwelling. The fenestration has been altered. The building is significant for its turn-of-the century, utilitarian design. It also is a local landmark, set on what has been a significant site for many years.

The Orme Store is now a multi-family dwelling. Located at the corner of Orme and Aquasco Roads, the structure faces Aquasco Road to its east. The Orme Store is a two-story frame, gable roof structure with a "T" shaped plan. The foundation is cement. The original horizontal wood siding has been covered with stucco. The roof is of standing-seam metal.

The three bay east facade faces Aquasco Road. The central entrance is flanked by two 6/6 windows on the first and two on the second story. The first story windows have narrow wood molding, wood sills and wood shutters screwed to the wall. The second story windows have wide plain wood surrounds with a wood sill and small crown molding. There are boxed, overhanging eaves.

The north facade has five bays with a gable end over the first bay. There is horizontal, brown painted siding in the upper gable. The cornice is returned. There is a second story door under the gable end, reached by an exterior metal stairway. Windows on the facade have been altered. The first story has a 6/6 window and an entrance on the fourth bay.

The west (rear) facade has a two-story shed roof addition on the rear gable end of the main structure. The upper gable has the same horizontal siding as the north gable. The two-story addition has boxed, overhanging eaves and five adjoining central 6/1 windows, forming a horizontal band, on the second story.

The five bay south facade has a first bay entrance. The fifth bay is beneath a gable end with horizontal siding in the upper gable. There is a corbelled brick chimney on the west slope of the roof. The fenestration is of varying size and has been altered.

There is a cement island which was used for gas pumps, in front of the building. To the east and north sides of the building the yard is a paved parking lot. There is a one-story, frame gable roof garage to the northwest of the building.

The Orme Store is south of Horsehead at what must have been a well-known location for local residents. because Emory Memorial Chapel and a school house were both once on approximately the same site.¹ The store is located on two acres called Orme. George E. Orme (1826-1894) owned a great deal of property in the area during the late-nineteenth century.² Orme is listed on the 1870 U.S. Census as a Justice of the Peace, owning real estate valued at \$5500. The store building does not appear on the 1878 Hopkins Atlas of the County. The two acre property was transferred from the Orme family to John B. Dale, a relative by marriage, in 1900.³ It is known that Dale kept a store on the site after that date.⁴ The property was owned by the Dale family through 1925.⁵ It has had a series of owners since that date.

The building has been altered to be used as a multi-family dwelling. The fenestration has been altered by the installation of modern windows and windows of varying size. The building is significant for its probable turn-of-the-century utilitarian design. It also is a local landmark in this rural section of the County. It served resident's needs for store-bought items, and it was built on what was a locally significant site for many years.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two-story, frame country house that apparently was operated as a store in this century. The main (east) section has a three-bay facade, with a central door and a steep A-roof. A shed-roof porch across the front has been enclosed on the NE corner. Windows are 6/6. The simple cornice is returned at the gable-ends. Siding is German siding. To the rear is a lower, two-story section that is recessed slightly to the north. This section has a stove chimney. Added to this part is a one-bay, two-story, shed-roof wing.






