Description:

This is a point of land that projects out into the Patuxent River, forming shallow coves on each side of the land. It is at the very end of Eagle Harbor Road, adjacent to the village of Eagle Harbor - which is a small, Negro resort community. The remains of pilings from the old steamboat wharf are still present. The wharf had a barn-like shed at the end, where tobacco and other goods could be sheltered from the elements. (See old photos in the Mariner's Museum, Newport News, Va.). Used mainly by fishermen today.


Significance:

Trueman Point served as the river port for Aquasco farmers throughout the 18th, 19th, and early 20th centuries. In 1747 it was named as a site for a state designated tobacco inspection warehouse. However, area inhabitants requested that the warehouse be located at Hannah Brown's Landing, known as Magruder's Landing, instead. Trueman Point apparently never had an official tobacco inspection warehouse, although it continued in use as a point for shipping tobacco and other merchandise.

In 1817 George Weems established the Weem's Steamboat Company of Baltimore, and acquired landings, including Trueman Point, up and down the Patuxent River. After Weem's death the company was continued by Mason Locke Weems and Theodore Weems. The Weems Line conveyed all its assets to the Maryland, Delaware and Virginia Railroad Company in 1905, at a cost of one million dollars. The Baltimore and Virginia Steamboat Company acquired the property in 1926 but went bankrupt in 1932. This appears to be the end of steamboat traffic at the Trueman Point wharf. From that time on the 9.6 acre property has been owned by individual property owners and has remained undeveloped.

SUBJECT: Recommendation for Historic Site Designation of Trueman Point, P.G. #87B-28

Trueman Point was a landing for Patuxent River trade during the 18th, 19th and early 20th century. There is no physical evidence remaining of its long history of use, however. For this reason, I believe that it does not fulfill any of the architectural criteria.

There may be some archeological evidence of its use as a tobacco shipping point from the 18th through the 20th century. Therefore, it could fulfill criteria 1 (a) and (d). It was not one of the ports of heaviest traffic during the 18th century, because it had no state designated tobacco inspection warehouse. Nottingham, Hill's Landing and Magruder's Ferry were more heavily used. From 1860 through 1932 Trueman Point was a stop for the Weems Steamboat Line as well as others. I cannot say what archeological investigation would produce, or that such investigation would enlarge our knowledge of 18th, 19th, and 20th century river trade.

It is worthwhile to note that at this time there are no designated historic sites to commemorate the Patuxent River trade. All the other landing places, like Trueman Point, have no architectural remains. P.G. #82B-25, Nottingham Archeological Site, is a National Register Site, however, it was studied and noted for prehistoric rather than colonial occupation.









This was the wharf at Trueman's Point, on the Patuxent River, about 1922. Trueman's Point was the southernmost Patuxent landing in Prince George's County, located near the village of Aquasco. During the twenties, two small communities, Crest Haven and Eagle Harbor, were laid out near Trueman's Point. They were built by black Washingtonians who wished to summer in the countryside.
