 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ginsburg House was located on the northwest side of the "square" in the center of Queenstown. The house and an adjoining store building were demolished in October 1977, shortly before the present survey was undertaken. This description is based on a verbal description by James T. Wollon (AlA) of Havre de Grace and a series of color slides taken by Chip Bohl (AlA) of Annapolis in October 1976.

The house was of brick construction, 2 1/2 stories high, five bays wide, and one room deep, with flush brick chimneys at each end of a pitched gable roof. A two story brick lean-to projected from the northeast end of the rear facade, and a small one story frame addition extended from the rear wall of the lean-to.

The front facade faced southeast across the square. The entrance door was centered on the first floor with 9/6 windows on the first floor and 6/6 windows on the second floor. The brickwork was covered with a coat of stucco; the eaves were finished with a box cornice, and the roof was

covered with asphalt shingles. A small entrance porch protected the door. On the northeast gable, there apparently was one 9/6 window to the right of the chimney, no openings on the second floor, and a pair of smaller windows flanking the chimney in the upper gable.

The northeast two bays of the rear facade was covered by the brick lean-to. A frame one story lean-to across the southwest wall of the rear lean-to covered the center bay of the main house on the first floor. There was one 9/6 window in the southeast bay on the first floor, and 6/6 windows in the southeast and center bays on the second floor.

The rear lean-to had also been covered with stucco. A stuccoed brick chimney protruded from the southwest corner of the wing. There was one 6/6 window centered on the second floor of the southwest wall. On the rear wall, the frame addition covered the left bay on the first floor, leaving one window opening to the right. Two 6/6 windows were symmetrically placed on the second floor.

Mr. Wollon recalls that the interior was relatively plain, with six-panel doors on the first floor and beaded

batten doors on the upper floor, but little else in the way of detail. The most significant features were the beaded joists reused in the first floor framing, visible from the cellar. These were placed both right-side-up and upside-down, and retained original wrought flooring nails.


