Description Summary:

The Female Seminary is a large 2-story gable-roofed brick building constructed ca. 1876 in a prominent location on a major thoroughfare in Centreville, seat of Queen Anne's County, Maryland. The building exhibits Victorian eclecticism in its combination of elements from various popular styles applied to a traditional side-passage floor plan. Despite the school's conversion for residential use in the early 20th century, its exterior retains integrity to reflect its original function and exhibits the careful craftsmanship typically applied to public buildings of the period in the region.

General Description:

The Female Seminary is located on the east side of South Commerce Street, one of the main streets in Centreville. It is constructed of pressed brick laid in common bond; the T-shaped building stands 2 stories high. The west façade, originally two bays wide, was altered in the early 20th century when the school building was converted to a pair of residences; a central window opening on the first floor was altered to a door and another door was installed in the north bay for a total of three entrance doors. The original entrance was located in the south bay of the west facade, with double paneled doors surmounted by a transom. The entrance bay projects forward slightly and rises to suggest a tower. The upper stage of the tower is lighted by a narrow four-over-four window surmounted by a semicircular brick arch and is capped with a hipped dormer. Three narrow four-over-four windows, grouped closely together, on each story originally lighted the south bay. A gabled dormer that contains signage with the designation "D.NO3 S.NO9" caps this arrangement. The gabled roof, originally cedar, is now covered in asphalt shingles.

The building was converted to residential use in the early 20th century. Windows with one-over-one sash were installed near the center of the west facade, and two one-over-one windows were added on the east facade to light the upstairs. A porch was added spanning the west facade.

On the south gable end of the main block, a group of three narrow windows is centered on each story. The three bays of the rear wing are defined by six-over-six windows on both stories. The east gable end of the wing has a shed-roofed porch across the first story; two entrances are offset to the corners, and the area of the porch between them is enclosed. Two one-over-one sash light the upper story.

The interior originally contained four classrooms, two on each floor, accessed by a side stairwell and passage. The stair, located at the southern junction of the main block and the wing, features turned balusters and newels. Bead-board wainscoting survives along the south wall of the stairwell.

When a transverse partition was installed to convert the schoolhouse to two residences, another stairwell was added at the center of building. Elements of the original decorative detailing such as door and window trim survive throughout the building. Original interior shutters and hardware remain on the windows in the upper northwest room. Original bead-board wainscoting remains exposed in the upper southeast bedroom and the bathroom adjoining that room on the west.

Summary Statement of Significance:

The Female Seminary is significant under Criterion A for its association with the development of education in Queen Anne's County in the late 19th century as the county's only public schoolhouse built exclusively for females. Built in 1876, the school was hailed as "an ornament to the town" of Centreville, the county seat, and reflects the county's civic pride and its interest in providing women with an education separate from their male counterparts. Despite its initial success—a ca. 1880 class photograph shows eighty-four female students and three teachers—this experiment in education proved short-lived. Within thirty years the county returned to teaching both sexes in the same building. In 1907, the schoolhouse—deemed "unsuited and unnecessary" for school purposes—was sold and converted to residential use.

The period of significance, 1876-1907, begins with the construction of the school and ends with the cessation of educational use of the building

Resource History and Historic Context:

In 1876, the year of the Centennial, and following the passage of several state school laws, the Board of County School Commissioners of Queen Anne's County undertook to provide a separate school building in Centreville for the instruction of girls. On the 8th day of August, 1876, the "female school board," consisting of Messrs. Nathan H. Green, John T. Hand and Wm. W. Busteed, organized and elected Mr. Busteed president." (Emory, Frederick, Queen Anne's County, Maryland, Its Early History and Development, Maryland Historical Society, 1950, p. 567). The following month, the board awarded Capt. James Smith a contract to construct a two-story brick schoolhouse on a parcel of land they had acquired two years earlier (Emory, p. 567; Deed, W.A.G.H. Liber 1 folio 254, October 23, 1874, Land Records of Queen Anne's County). In his report to the state superintendent in 1876, James W. Thompson, Secretary to the Board of County School Commissioners, wrote that

We have under contract a school house in Centreville, in which we expect to open a Female Graded School. We have needed this school for years, but as our motto has been "pay as you go" we have not been able to open it before. The house when built will be the only school property in the County Town belonging to the Board, while every village in the County has a schoolhouse. The house will be two-stories high, built of brick, an ornament to the town and a credit to the Board (DeVilbiss, Dr. Wilbur, "Education in Maryland with Particular Reference to Queen Anne's County", lecture to the Queen Anne's County Historical Society, n.d.)

The cost of the building was set at \$1725 ("Public Education Starts One Year After Paper", *Record Observer*, May 1958). The contract for the two-story brick school-house was awarded to Capt. James Smith in September,

1876 (Emory, p. 567). Early maps including the 1877 map of Centreville and the Sanborn Fire Insurance Map of 1885 show a school building on the lot. The 1877 map of Centreville shows the lot shaded pink, as are the other public buildings in Centreville, and the school is labeled as "No. 15 Female Seminary" (The 1877 Atlases and Other Early Maps of the Eastern Shore of Maryland, Bicentennial Edition, 1776- 1976, pp. 126, 107).

The collection of the Queen Anne's County Historical Society includes two historic photographs taken in front of the school. The earlier picture, ca. 1880, shows a class of eighty-four female students and three teachers. The students appear to range in age from approximately five to fifteen. Their dresses are worn below the knee or longer ankle length and their hair is usually worn pulled back in a bun. The second picture, ca. 1895, shows a class comprised of forty-one male and forty-nine female students. The students appear more expensively dressed. The girls wear shorter dresses, often with sailor ties and large bows, while the boys wear mostly jackets and ties. In both pictures chalk graffiti is apparent on the front of the school, and a great mass of ivy or Virginia creeper grows up the middle of the schoolhouse.

Thirty years after the school's construction, the idea of separate public education for females had fallen out of favor, and the building became obsolete. Stating that the property had "become unsuited and unnecessary for school purposes", the Board of County School Commissioners of Queen Anne's County sold the back half of the property to Robert R. Price, for four hundred dollars. The deed was signed by James W. Cookman, as President of the Board of County School Commissioners of Queen Anne's County (Deed, J.E.G. Liber 3 folio 101, March 29, 1902, Land Records of Queen Anne's County). Five years later the Board of County School Commissioners sold the remaining front half of the property, referred to as the "Primary School Lot", to J.H.C. Legg for two thousand dollars (Deed, W.F.W. Liber 4 folio 557, March 10, 1907, Land Records of Queen Anne's County). Thus ended Queen Anne's County's provision of a separate education for its female students, although a private institution continued to offer secondary education for female students for several decades thereafter.
