The Perry Building is primarily significant as an example of a small Victorian commercial building. The decorative store-front facade has survived completely intact, and is distinguished by a bracketed cornice and bands of glazed header brickwork. A datestone in the upper gable identifies both the date of erection, 1895, and the original owner, John W. Perry. It is interesting to compare the recessed brick panels and glazed header decoration of this building with similar features on Perry's residence, located at 201 South Commerce Street (QA-257).

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Perry Building, located at 112 Water Street in Centreville, is a two story brick building with a distinctive Victorian commercial store-front on the street (south) facade. The first floor of the building has traditionally served as a shop or store, while the second floor and two additions to the rear provide private living quarters for the owner or for tenants. The street facade is the primary architectural feature of the building, while the side and rear walls are extremely plain.

The street facade is three bays wide and two stories high, constructed of red brick laid in seven-course bond. Bands of glazed header bricks on the second floor and recessed panels highlighted with glazed headers add an unusual touch of refinement. The shop entrance is located in the center bay, and is recessed back from the front wall. Tall narrow windows flank the door, and larger shop windows in the flanking bays dominate the first floor facade. A bracketed Victorian cornice crosses the gable directly above

STATEMENT OF SIGNIFICANCE

The Perry Building is primarily significant as an example of a small Victorian commercial building. The decorative store-front facade has survived completely intact, and is distinguished by bracketed cornices and bands of glazed header brickwork. A datestone in the upper gable identifies both the date of erection, 1895, and the original owner, John W. Perry.

The lot on which the building stands is part of a larger lot purchased by John W. Perry in 1883.⁽¹⁾ The building was erected in 1895, only three years before Perry's death.⁽²⁾ In 1899, John M. Perry, acting as executor for the estate, sold the lot and "a two story brick store house" to Dora E. P. Chambers. No mention is made of what the store had been used for, but the deed noted that it has been recently occupied by Otto H. Werner, and was, at the time of the sale, in

the first floor, and on the second floor there are a pair of two-over-two windows in the center of the facade. The gable is pedimented, with an ornate bracketed cornice crossing the gable and a box cornice carried up the gable eaves. The scrolled brackets and sawtooth fretwork serve to unify the pedimented gable with the first floor cornice. A louvered fan-light ventilator is located in the center of the upper gable, and a large rectangular datestone is incorporated into the second floor cornice. This stone is inscribed with the initials of the first owner, John W. Perry, and the date 1895.

The east wall of the building is completely covered by an adjoining commercial building, but the west wall remains exposed, with access to a narrow alley extending the full depth of the property. The later additions are clearly visible on this facade. The original building was built in seven-course bond, and now has a door near the rear on the first floor, and two two-over-two windows on the second floor. The door opening appears to have been cut in when the building was enlarged to the rear. This addition was also two stories high, and probably added one

more room on each floor. It is laid in seven-course bond, with a single two-over-two window in the center on each floor.

The second addition extended the building three more bays to the rear, but was only one story high. It is also brick, laid in seven-course bond, and may have originally had a sloping shed roof pitched from east to west. There is a door in the center bay of the west wall flanked by two-over-two windows. On the rear wall, there is a door in the extreme west corner, and a brick stove chimney rises immediately to the left of the door. This chimney is somewhat unusual in that it corbels out 4 inches from the wall surface approximately four feet above ground level.

The final addition to the building involved raising the one story rear wing to a full two stories. This was executed in frame rather than brick, and is now covered with wood shingle siding. There are two two-over-two windows in the west wall of this addition, and one two-over-two window to the right of the chimney on the rear wall.

The interior is extremely plain, and continues to serve as both a shop and residence. The present

owner maintains the first floor as a shoe-repair shop, while the second floor and the rear additions are rented as apartments.

the occupancy of Dora Chambers, the purchaser.⁽³⁾
When Dora Chambers sold the lot and building to William L. Clough in 1911, the deed noted that it was "formerly in the occupancy of Dora Chambers but now in the occupancy of Arthur Morris."⁽⁴⁾ In 1945, William L. Clough sold the property to William R. Turner and Mary Frances Turner.⁽⁵⁾ The Turners sold it to Paul and Dorothy Amberger in 1967,⁽⁶⁾ and in May 1968, the Ambergers sold the property to William F. Mayer and Dorothy A. Mayer, the present owners.⁽⁷⁾


