This two and one-half story shingled residence contributes to the Centreville Historic District. It is consistent with the scale, massing, form and details of the historic district, and is within the period of significance. It features a gabled roof, 2 over 2 windows and narrow eaves. Similar to some other houses in the district the side gable is to the street and porch runs along one side. The cedar shingle siding is also characteristic of many residences within the district. The building maintains sufficient integrity to contribute to the historic district.
