DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Nash House was located on the north side of U. S. Route 50 just east of Piney Landing Road on Kent Island. The house was vacant in 1977 when it was recorded by James T. Wollon, Jr. as part of a survey of Kent Island architecture organized by Mildred Schoch of Chester. The house was heavily damaged by one fire and in June 1978 it was burned to the ground by the Kent Island Fire Department. The following architectural description was prepared by James T. Wollon, Jr. in March 1977 and is quoted from his report:

"The NASH HOUSE is a frame house of traditional design, built in two sections: to the east is a one and one-half storey section dating from the second quarter of the nineteenth century; to the west is a two storey section, the first storey of which may be contemporary with, or slightly later than, the east wing, raised to its present form late in the nineteenth century.

A large brick chimney is within the west end of the east or kitchen wing, with a large fireplace in the kitchen, now closed. An enclosed stairway winds to the attic storey north of the chimney. The exposed

STATEMENT OF SIGNIFICANCE

The Nash House is typical of a house form found throughout the Tidewater region, consisting of a two story, five bay frame house with a small story-and-a-half frame wing projecting from one gable. It is interesting to note that the wing may be earlier than the main house, and that the upper story of the two story section was a later addition.


