DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This parcel of land to the southeast of the intersection of Johnny Powell Road and Maryland Route 300 was the site of the log house moved in 1965 by Med Baxter to a new site on the west side of Maryland Route 290 near Pondtown. The house consisted of two parts, a hall-parlor house with a gambrel roof and a pitched roof wing constructed of post-and-nogging. The gambrel roof section was moved in 1965, while the pitched roof wing was considered to be beyond repair. This section of the building was left on the original site and was eventually demolished. For a more complete description of the building see QA-46.
