Description:

The property was known as the John Henry Hynson Place prior to its sale by a Hynson heir in 1921. Centered on a frame dwelling, the property comprises a half-acre plot of land at 6300 MD 18 (Main Street) in Queen Anne's County, on Maryland's Eastern Shore. The simple, much altered frame house is ell-shaped with two rear additions perpendicular to the main block. There are no original ancillary buildings remaining on the site that contribute to its significance. Two small sheds, metal and frame, plus a large metal storage structure (all of modern construction), are located to the rear of the dwelling.

Significance:

This house is a common type in rural Maryland and locally along MD 18 in the vicinity of Queenstown. It has been altered from its original form by numerous changes made by the previous and current owners which has undermined its integrity. It is not known to be associated with significant historic events or persons. Therefore, it is not significant under Criteria A, B, or C for listing in the National Register.

Description Summary: The property was known as the John Henry Hynson Place prior to its sale by a Hynson heir in 1921. Centered on a frame dwelling, the property comprises a half-acre plot of land at 6300 MD 18 (Main Street) in Queen Anne's County, on Maryland's Eastern Shore. The simple, much altered frame house is ell-shaped with two rear telescoping additions perpendicular to the main block. There are no original ancillary buildings remaining on the site that contribute to its significance. Two small sheds, metal and frame, plus a large metal storage structure (all of modern construction), are located to the rear of the dwelling.

Description: This frame dwelling is located on a half-acre plot of land at 6300 MD 18 (Main Street) in Queen Anne's County, on Maryland's Eastern Shore. It is located on the north side of MD 18, at the end of a string of mid-to-late-twentieth century frame dwellings. MD 18 is the ancestral route from Grasonville to Queenstown, which was bypassed by US 50. The community is a small, linear, residential enclave within a largely rural portion of the county. Nonetheless, there is a large shopping complex located to the north east of the community that has changed and will continue to change the character of the area. The alteration of the surrounding environment will be exacerbated by the projected expansion of that shopping complex to the south side of US 50.

The simple, much altered frame house is ell-shaped with two rear additions perpendicular to the main block. It is clad with shingles. The cornices are boxed and there are cornerboards on the northwest and southwest corners. A one story shed roofed addition is located in the northeast angle of the main block and the addition. The principle addition is two stories, and a one story gable-roofed addition is located off the east or rear elevation. The main block is two and one half stories supported on granite corner blocks. Its roof is side-gabled, with one interior brick chimney remaining inside of the south end wall. The roof is clad in composition shingles. The windows are six-over-six, double-hung sash throughout the house with the exception of the round arch window in the cross gable, the larger window in the north elevation, and the small octagonal window in the north elevation of the rear wing.

The west (principal) elevation has three bays, with a cross gable over the centered entrance. The apex of the cross gable is the location of a lathe-turned pendil, a bargeboard feature.

The cross gable is pierced with a round-arch two-over-two window. The first floor window in the north bay has been removed. The front door is a contemporary replacement of the original. The north elevation is the location of a single, larger replacement sash window in the main block, two windows at the second level of the ell over the shed-roofed infill area, which is the location of a door and an octagonal window. The fenestration of the south elevation is *regular*, with an entrance located in the east bay of the two-story ell, and a projecting glass shell placed over the lower window in the third bay.

Extending the ell is a one-story frame side-gable addition with exposed rafter ends. A doorway in the south elevation has been removed. There are no original ancillary buildings remaining on the site that contribute to its significance. Two small sheds, metal and frame, plus a large metal storage structure (all of modern construction), are located to the rear of the dwelling.

The property was known as the John Henry Hynson Place prior to its sale by a Hynson heir in 1921 (Land Record JFR7/217). Originally encompassing 8 acres (Lot #2, Land Record SCD10/285), it was reduced to a half-acre in the most recent sale (1982). A 1959 survey (NBW2/340) shows three chicken houses and a small barn on the property immediately to the east of the dwelling. None of the former outbuildings associated with the structure are extant and their original locations are currently occupied by housing accessed by short lane.

The current owners, Mr. Schultz and Ms. Emerson, report that when they purchased the property in 1982 it had been vacant for *two* years and *was in* a state of disrepair. They reported (personal communication with Rita M. Suffness, 12/11/1986) that the dwelling, constructed in 1908, was extensively altered in 1930. At that time the structure was shingled, a central chimney in the middle of the structure was removed, the exterior porch and the interior stairs were removed, original plaster replaced by wallboard, and some of the interior walls were relocated. The original windows and interior finishing materials were also replaced. The building was electrified in 1938. They further reported that with their acquisition of the property they enlarged all doorways to 36 inches, and all of the floor joists were replaced. A six-foot high bathroom in the northeast corner was raised to a full height, a new laundry/bathroom was added, and the covered porch in the north angle of the main block and the ell was enclosed and re-fitted as a kitchen.

Statement of Significance

The John Henry Hynson House Farm, constructed ca. 1908, is associated with the period of Industrial/Urban Dominance (AD 1870-1930), and the themes of Agriculture and Architecture. The Hynson House was evaluated under National Register of Historic Places (NRHP) Criteria A, B, and C to determine its eligibility for listing in the NRHP and the Maryland Inventory of Historic Places (NUHP). The Hynson House is a common architectural type in rural Maryland. It lacks significant architectural distinction and has lost considerable integrity. There is no known association of the farm with significant historic events or persons. Therefore, the Hynson House is recommended not eligible for listing under Criteria A, B, or C.

The Hynson House is situated southwest of Queenstown on the ancestral road leading from Grasonville to Queenstown before the construction of US 50 to Wye Mills, and points further south. Queenstown served as the seat of Queen Anne's County from 1706 until 1782, when Centreville was chosen as county seat. Queenstown, however, retained its importance as a center for local trade during the late nineteenth and early twentieth centuries. The Hynson House was constructed during the period of Industrial/Urban Dominance (AD 1870-1930), during which the economy of Queen Anne's County was based primarily on agricultural goods, such as grains and fruit, and some agriculture-related industries, such as canneries. It is likely that Hynson Farm was operated as a small self-sufficient farm that produced agricultural goods for subsistence and sale. The expansion of the regional transportation network, with rail and Steamboat service, provided the residents of Queen Anne's County easier and more rapid conveyance of agricultural products to industrial centers, such as Baltimore and Philadelphia. Steamboat service was available from Queenstown to Baltimore beginning in 1820 until 1916. In 1896, railroad service also became available locally. The Queen Anne's Railroad initially operated between Queenstown and Denton, but was extended to Lewes, Delaware in 1898. There were several stops in the vicinity of the project area, such as Bloomingdale, and Wye Mills. In 1902, the line was expanded from Queenstown to Love Point on Kent Island, and also north from Queenstown to Centreville. The railroad became the dominant means of transportation during this period, and encouraged settlement and creation of towns, though many of these failed (Wesler et al. 198 1).




