This c. 1870 two-story frame building stands along the south side of MD 361 among the largest concentration of houses in Lower Fairmount. The structure rests on a minimal brick foundation and is covered with a gable-front asphalt shingle roof. The eaves are extended and embellished with brackets. The main facade is pierced by five openings, three on the first floor and two on the second. A center door is flanked by 2/2 sash windows, but the second floor is lighted by 6/6 windows.

A single story shed addition extends the building to the west (side) and south (rear).


