Marking the southwest corner of the Green Hill crossroads is this mid 19th-century granary and wagon house. The single-story mortise and tenon frame structure is partially sheathed with flush horizontal boards and is covered by a sheet tin roof. Board and batten doors with long strap hinges are located on both levels. Extended to the north is a single-story hyphen which connects a weatherboarded frame wagon house with a gable front roof. The interior of the granary has an exposed mortise and tenon framing system. An open stair rises in the eastern corner of the building to the second floor loft. The granary as well as the store across the road (S-206) are featured on the 1896 plat of the property of Francis Barnes.

The Green Hill Granary is a third quarter of the 19th century single-story frame granary which stands on the southwest corner of the Green Hill crossroads, directly opposite the Green Hill store. The structure faces northeast with the gable running northeast to southwest.

The single-story mortise and tenon frame is partially sheathed with flush horizontal boards and is covered by a sheet tin roof.

The northeast (or main) elevation is three bays across. A wagon bay occupies the opening to the left (or south) while the remaining openings are covered with board and batten doors. The center door has mass-produced hinges with round-butt ends, while the door to the right (north) and the loft door have spade tipped wrought hinges.

The southeast side of the granary is sheathed with vertical siding.

The southwest gable is treated in a manner similar to the front.

Extended to the northwest is a single-story gabled hyphen which connects a weather-boarded frame structure with a gable-front roof.

The interior of the granary has an exposed mortise and tenon framing system. An open stair rises in the eastern corner of the building to the second floor loft.
