This abandoned house does not carry much architectural significance outside the fact that it is a companion structure to the Captain William H. Veasey House (S-223) standing next to it. These two houses stand within a hundred yards of the Pocomoke River and were obviously active waterfront sites at one time. Remnants of beaded weatherboards survive on the front elevation, and the interior is finished with mid 19th-century woodwork.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This c. 1860-1870 two-story two-bay by one-room frame house stands next to the Captain Veasey House (S-223), only closer to the Pocomoke River. It faces east with the main roof running on a north/south axis. A brick pier foundation supports the mortise and tenon side hall/ parlor structure, while a combination of beaded and plain weatherboards sheath the wall surfaces. The steeply pitched roof is covered by asphalt shingles. A two-story two-bay service ell extends to the rear which has a single story one-room addition attached to it.

The east (main) facade has the most beaded weatherboards. A four-panel door opens into the side hall, while 6/6 sash windows light the first and second floors.

The south gable end has an interior end brick chimney with flanking 2/2 sash windows on each floor. The north gable end has a single 6/6 sash on each floor including the attic.

Extending to the rear is the two-story two-bay kitchen which is covered on the north side by a two-story porch. An interior end brick chimney rises from the gable.

Entrance into this house was not gained, but the detailing appeared to date from the third quarter of the 19th-century.


