The Old Butler Farm is located on the east side of Cokesbury Road just south of the Cokesbury crossroads near Pocomoke City, Worcester County, Maryland. The two-story c. 1900-1910 farmhouse stands on a prominent rise of land between the road and Dividing Creek.

Facing west the two-story gable-front frame house rests on a brick pier foundation and is covered by a steeply pitched asphalt the roof with exposed rafter feet.

The weatherboards are covered by a uniform layer of asbestos shingles. A brick chimney rises from the center of the house.

Accompanying the house is a group of contemporary outbuildings including a board and batten frame chicken house a smokehouse, a delapidated corn crib and a wagon shed.

The west elevation is three bays across with an entrance in the south or right bay. The door is glazed above the lock rail and paneled below. The two adjacent openings are filled with single-pane sash windows. The second floor is lighted by three 2/2 sash windows and the attic has one 2/2 sash window. Stretching across the first floor and around the south side is a turned post porch with decorative trim between each post head. A small gable distinguishes the entrance bay, and it is decorated with sawn work. A star design is centered in the peak.

The south side has a two-story three-sided bay pavilion that is covered by a gable-front roof. The roof soffits on each corner are decorated with sawn work.

The east (back) side has a simple shed addition, while two 2/2 sash windows light the second floor, and a single 2/2 sash window lights the attic.

The north side is a plain wall with the same 2/2 sash windows or replacements on each floor.

The interior is being moderately remodeled at present, but most of the period woodwork is being saved.

The outbuildings stand within twenty yards of the kitchen door and are plain early twentieth century structures. According to the owner, the 18th-century house site is located next to the old pear tree that stands due east of the present farmhouse. The old house was moved up to a new site in the early 20th-century and used as a barn, until a wind storm twisted the frame. It was finally demolished several years ago.
