The Hope Farm is located on the northeast side of Cokesbury Road, .4 of a mile southeast of the Cokesbury crossroads near Pocomoke City, Worcester County, Maryland. The c. 1900-1920 Victorian period farmhouse faces southwest. The outbuildings associated with the farm have been removed from the property.

The two-story T-plan frame house rests on a brick pier foundation and is largely sheathed with narrow weatherboards. The steeply pitched roof is covered with asphalt shingles, while the wraparound porch is covered with patterned slate. An interior brick chimney rises from the central portion of the house.

The southwest elevation consists of the projecting three-bay leg of the T and a single bay to each side. A partially glazed door is situated in the right or south bay, and the remaining openings are filled with single-pane sash windows. A strip of decorative trim is applied to each of the door and window headers. The turned post front porch has a centralized gable also covered with patterned slate. The porch encircles the leg of the T and provides access around to each side door. Located in the upper gable is one single-pane sash window along with decorative sawnwork.

Both gable ends are similar with one single-pane sash on each floor and decorative trim in the eaves.

The back (northeast) side is largely covered by a two-story shed roofed addition, which has an open second story porch. The balance of the addition is covered with weatherboards and lighted by single-pane sash windows.

The interior of this house was not open for documentation on a first, unannounced visit.

The Hope Farmhouse is a well-preserved two-story Victorian dwelling with an unusual T-plan. Most farmhouses in the immediate vicinity are simple gable front structures (See S-228), or traditional two-story three-bay I-house forms. A structure appears to be located on this site in 1877, but local tradition and architectural evidence suggest an early 20th-century date of construction. No outbuildings have survived.


