School No.4 is sited on the north side of Shelltown Road a mile and a half south of Rehobeth. The single-story gable front frame building is supported by a brick pier foundation and trimmed with narrow corner pilasters. The southwest side has six large scale windows that were added around 1920 in an effort to increase the amount of natural lighting. It is thought that this school was the first to accomplish these lighting changes imposed under state standards.

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

School No. 4 is located on the north side of Shelldown Road approximately a mile-and-a half south of Rehobeth, Somerset County, Maryland. The single-story one-room plan frame school faces southeast with the gable running on a northwest/southeast axis.

The c. 1860-70 rectangular frame school is supported by a brick pier foundation, and it is sheathed with horizontal weatherboards. A medium sloped roof is covered with a layer of asphalt shingles. The eaves are extended and the cornices are boxed.

The southeast (main) facade is marked by an enclosed gabled entry. Corner pilasters frame the elevation.

The southwest (side) elevation is distinguished by a series of six off-center 6/6 sash windows installed at a slightly later date to add more light inside.

The northwest gable end is a plain weatherboarded wall without distinguishing features.

Finally, the northeast (side) has three window openings that have been reduced in size from large size 6/6 sash to small square windows. A narrow brick stack rises from the center portion of the structure.

The one-room interior has been generally remodeled for migrant labor housing. The brick stack rests on a metal support post.



The exterior was altered slightly around 1920 to accomodate larger windows for state regulations. It is generally thought this school was the first to accomplish these standards imposed under state guidance.
