Commanding a fine view of the Manokin River, the John Myers house is a plain two-story, two-room plan farmhouse sheathed with asbestos shingles. The turn of the century dwelling is finished in a modest manner without any exterior or interior decoration. The two-room plan front block is extended to the rear by a large two-story service wing, where the stair rises to the second floor.

The John Myers farmhouse stands in the middle of a field on the north side of the Manokin River and at the east end of the Thornton farm lane, near Princess Anne, Somerset County, Maryland. The two-story, three-bay farmhouse faces south with the principal gable running on an east/west axis.

Built around the turn of the century, the asbestos clad frame house is supported by a brick pier foundation and covered with a medium pitched asphalt shingle roof. Attached to the north side of the house is a two-story service wing.

The south (main) facade is an asymmetrical three-bay elevation with a partially collapsed shed roof porch. The east end of the porch is enclosed. A partially glazed front door is flanked on the left by a two-over-two sash window. The second floor is lighted by a pair of two-over-two sash windows on each end and a small square center window. The eaves are extended, and the soffits are sloped. Rising through the center of the house is an internal brick stove stack which has been leveled off above the roofline.

The gable ends are essentially alike with a single two-over-two sash window on each floor, and a small two-over-two sash window lights the attic.

The north side of the main block is largely covered by a two-story, three-bay frame service wing with an off-center brick stove stack. The first and second floors are lighted by two-over-two sash windows.

The first floor of the front section is divided into two rooms, while the stair rises in the back wing of the house. Finish details throughout the two sections are relatively modest.


