Located north of Princess Anne and east of the old Pennsylvania railroad line is the Pinto farm, which has remained in the same family since the early nineteenth century. Although Zadock Long purchased several tracts of land in 1803 and evidently financed the construction of the early, southern half of this two-story frame house, it is documented that he lived elsewhere. (See Catalpa farm) Instead, the property was occupied by Zadock Long's daughter, Leah Whittington Long and her husband, John V. Pinto. After Zadock Long's death in 1838, the farm was devised to Leah, and her husband, John, and in the event of their deaths the will bequeathed the property to the grandchildren, Matilda W. and John E. L. Pinto. The farm was eventually partitioned in February of 1869 between John V. Pinto and Matilda, since John E. L. had sold his interests in the property. A month later John V. Pinto was dead, and the farm passed to the next generation of family owners.

Although the side hall/parlor house has been reworked recently, the house survives with an early nineteenth-century stair, flush six-panel doors, Federal style mantels and chair rail. A combination of wrought and double-struck cut nails suggests the early nineteenth-century date of construction.
