The Kitty Handy house stands out prominently in the historic black community of Upper Hill. Raised on an elevated brick foundation, the tall two-and-a-half story, cross gabled dwelling follows an architectural form common to Somerset County and Upper Hill. Built on a center hall/single-pile plan, the main block is extended to the rear by a two-story service wing. The construction of the house is estimated to date to the turn of the twentieth century. Pointed arch attic windows, narrow brick stove chimneys, open eave soffits, and two-over-two sash windows are features that reasonably place its construction around 1900.

Chain of title research, coupled with local oral history, document this house as the former residence of Kitty Handy. Officially recorded in a 1922 transfer of the property is Laura J. Handy, who purchased this house and one acre from William H. Adams.

The Kitty Handy house, also known as the Laura Handy house, is located at 8154 Upper Hill Road in the center of the historic black community of Upper Hill, Somerset County, Maryland. The two-and-a-half story three-bay, cross gabled frame house faces east with the gable roof oriented on a north/south axis.

Dating to the turn of the twentieth century, this two-and-a-half story, three-bay single pile frame dwelling is supported on raised brick pier foundation sheathed with sheet metal covering. A layer of asbestos shingles cover the original weatherboard siding, and a sheathing of asphalt shingles cover the steeply pitched gable roofs. Attached to the back of the center hall plan main block is a two-story kitchen wing.

The east (main) facade is a three-bay elevation with the first floor sheltered by a single-story porch. The partially glazed front door is flanked by two-over-two sash windows. Lighting the second floor are three evenly spaced two-over-two sash windows, and the cross gable is pierced by a pointed arch two-pane attic window. The eaves to the roof are extended and the rafter ends are exposed. Rising through the roof and flanking the center hall is a pair of single flue brick stove chimneys finished with corbeled caps.

The north and south gable ends are largely alike with single two-over-two sash windows centered on each floor, and a pointed arch two-pane window lights the attic. The bargeboard that trims the gable end is finished with a slight decorative cut-out finish.

Attached to the back side of the single-pile main block is a two-story, one-room plan kitchen wing supported on the same raised foundation. A single-flue brick chimney rises through the gable end and a single-story shed roofed addition extends from the south side.

The interior was not seen.






