Located on the southern side of the historic black community of Upper Hill, this story-and-a-half frame bungalow is a well preserved example of early twentieth century domestic architecture as interpreted in a rural village on the Fairmount peninsula. Reflective of this popular early twentieth century design are the story-and-a-half elevations, the medium pitched gable roof, the large dormer that adds space and light to the second floor, and the Craftsman style details. In particular, the exposed rafter feet and the eave brackets shaped in the form of cantilevered purlins, point to a hand-crafted appearance advanced by architects, builders, and trade literature as inherent to the style. The bungalow style houses in Upper Hill, which date from around 1910 to 1930, comprise the first major shift from the center hall or side hall/single-pile houses that had served community residents since the third quarter of the nineteenth century.

The Willie A. Waters house stands at 8129 Upper Hill Road in the historic black community of Upper Hill, Somerset County, Maryland. The story-and-a-half frame bungalow faces west with the gable roof oriented on a north/south axis.

Dating around 1927, this story-and-a-half frame house is supported by a raised common bond brick foundation, and the exterior is clad with vinyl siding. The low pitched gable roof, extending in front and back to include engaged porches, is covered with a layer of asphalt shingles. Piercing the roofline is a single flue stove chimney.

The west (main) elevation is comprised largely of an enclosed porch with large square posts supporting the roof. The rafter ends of the roof are exposed. Centered on the medium pitched roof is a large gabled dormer with exposed rafter ends. A triple set of single-pane sash windows pierce the front wall of the dormer.

The north side of the bungalow features a single-story shed roofed extension of the back room. This small shed extension is marked by three three-pane windows. Paired three-over-one sash windows pierce the wall to the right of the bay extension. A three-over-one sash window lights the second floor.

The south side of the bungalow is detailed in a less elaborate fashion with three-over-one sash windows lighting the first and second floors.

The interior was not seen.






