Currently known as the Franklin Johnson house, this two-story three-bay frame dwelling has been held by various member of the Johnson family since the turn of the twentieth century. Chain of title research for the property traces the ownership to Franklin Johnson's uncle and aunt, John and Mamie Johnson, who purchased the property in May 1944. Early twentieth century deeds refer to a former owner, Chris Johnson.

The architectural features of this frame dwelling place its construction around the turn of the twentieth century. Similar to many houses in Upper Hill, the rectangular frame structure is two-stories tall and one room with two-over-two sash windows lighting the first and second floors. The steeply pitched gable roof is finished with extended eaves. These essential features are repeated by many houses in this historic black community and contribute to the turn of the twentieth century character of the village.

Historically identified as the Chris Johnson house, and currently known as the Franklin Johnson house, is this two-story, three-bay frame house that stands at 27849 Jim Moore Road in the black community of Upper Hill, Somerset County, Maryland. The two-story, three-bay frame house faces west with the gable roof oriented on a north/south axis.

Dating around 1890, this two-story, three-bay, single-pile frame dwelling is supported on a low brick pier foundation covered with sheet metal. The exterior is clad with vinyl siding, and the steeply pitched roof is covered with asphalt shingles. Attached to the back (east) side of the single-pile house is a single-story kitchen wing.

The west (main) facade is a three-bay elevation with the first floor largely covered by an enclosed shed roof addition erected by the current resident, Franklin Johnson. It covers the two southern bays of the first floor with a side entrance marking the north wall. A two-over-two sash window, not covered by the enclosed addition, lights the first floor, and three two-over-two sash windows mark the second floor. Rising through the center of the house is an interior concrete block stove flue. The base to the roof is finished with a boxed cornice.

Each gable end features a single two-over-two sash window on the first and second floors, and small attic windows mark the upper gable end. The gable end eaves are extended and the soffits are enclosed.

The west (rear) wall of the main block is partially covered by a single-story, one-room plan kitchen wing. The portion of the wall not covered by the kitchen is pierced by two-over-two sash windows on each floor, and a single-flue concrete block chimney rises against the northeast corner of the main block.

The kitchen is a squarish single-story structure covered by a steeply pitched gable roof lighted by two-over-two sash windows. A concrete block stove chimney rises against the east gable end.

The interior was not seen.






