The Edward D. Waters house stands at the end of Davy Lane in the historic black community of Lower Hill, Somerset County, Maryland. The two-story, two-bay frame house follows a side hall/parlor plan that is common to this region of watermens' communities. The four-panel front door, as well as the two-over-two sash windows and the narrow brick stove chimney finished with a corbelled cap, are finish features typical of the late nineteenth and early twentieth centuries.

An exact date of construction, nor a full chain of title, have been established for this property. The earliest deed reference for the house and lot were executed on June 11, 1921 between Edward D. Waters and Emory D. Waters. Twenty-three years later, on June 1, 1944, the property was acquired by Flossie W. Jones, who retained title until September 1972.

The Edward D. Waters house stands at 27387 Davy Lane in the historic black community of Lower Hill, Somerset County, Maryland. The two-story, two-bay frame house faces north with the gable roof oriented on an east/west axis.

Built around 1890-1900, the two-story, two-bay side hall/parlor frame dwelling is supported by a low brick pier foundation covered with metal sheathing. The house is uniformly clad with vinyl siding, and a medium sloped asphalt shingle roof is finished with extended eaves and sloped soffits. Attached to the back of the main block is a two-story service wing.

The north (main) elevation is a two-story, two-bay facade with a side entrance marked by a four-panel door. A two-over-two marks the bay to the right. The second floor is lighted by a pair of two-over-two sash windows. Rising through the roof is a single-flue brick stove chimney finished with a corbelled cap.

The east and west gable ends are largely alike with a pair of two-over-two sash windows lighting the first and second floors. The eaves to the roof extend slightly beyond the plane of the gable end wall and are boxed.

The south (rear) wall is largely covered by a two-story, two-bay by one room ell service wing, which is extended on two sides. A shed roofed enclosed porch is attached to the west side and a single-story gable roofed addition is attached to the back of the kitchen.

The interior was not seen.






