The Theodore Waters house stands on the south side of a dirt road known as Davy Lane, named in an effort to recognize a former nineteenth century landowner, Captain George Davy. Captain Davy owned a large portion of the land surrounding the Lower Hill community during the second half of the nineteenth century and his name is found in several locations on the Lake, Griffing, and Stevenson Atlas (1877). The architectural features of this two-story frame dwelling place its construction during the late years of the nineteenth century or first decade of the twentieth century. For much of the twentieth century this property has been owned by the Waters family, first purchased in 1903 by Graham Waters. Two long-time resident owners include Moody S. Waters and his wife Elsie, who owned the property between 1906 and 1949 and Theodore and Beulah Waters, who acquired the house and lot in December 1949.

The Theodore Waters house, historically known as the Moody S. Waters house, is located on the south side of Davy Lane in the community of Lower Hill, Somerset County, Maryland. The two-story, two-bay frame house faces north with the gable roof oriented on an east/west axis.

Dating around 1890-1900, the two-story, two-bay side hall/parlor frame dwelling is supported on a low brick pier foundation covered with sheet metal. The exterior is clad with vinyl siding, and the steeply pitched roof is sheathed with asphalt shingles. Attached to the back of the front block is a two-story, two-bay kitchen wing.

The north (main) facade is a two-bay elevation with a side entrance and flanking two-over-two sash window. An enclosed shed roof front porch shelters the first floor. The second floor is lighted by a pair of two-over-two sash windows. The base of the roof is finished with an extended eave and sloped soffits.

The east and west gable ends are defined by a single two-over-two sash window on each floor, and the gable end is finished with an extended eave.

The south (rear) wall of the main block is largely covered by a two-story, two-bay service wing that is extended on its west side by a single-story shed roofed addition. The east side of the kitchen wing is marked by side entrance and a two-over-two sash window. Rising through the gable end is an interior end concrete block stove chimney.

The interior was not seen.




