In November of 1837, William Wallace sold parts of three tracts to William Price of Dorchester County. Included in the deed was part of a tract called, "Graves End," part of "Barbadoes," and part of "Self Preservation" (OIB 21/380). During the following few months William Price financed the construction of this two-story, transverse hall dwelling finished in late Federal/Greek Revival taste. William Price continued to reside in the house until the time of his death, but in 1883, William Price transferred ownership of his property to Addie W. and L. May Bradshaw to reconcile debts (BFL 5/534). After William Price's death around 1885, the property passed from the Bradshaws to William Damerel in 1887 (HFL 4/661). After the turn of the century Barnie G. Shores owned the parcel until 1937, and afterwards the house was owned by Eddie and Edith Shores until 1972.

The William Price house is a modest example of the Federal/Greek Revival style dwellings found throughout Somerset County. Dating from the 1830s, this transverse hall house is one of the oldest dwellings to remain standing in the Wenona vicinity. The Palladian window that pierces the gable front pediment is an unusual feature not shared by other houses of the same form.

William Price House Description

The William Price house stands at the end of a private dirt lane which intersects the Deal Island Road (MD 363) at the north end of Wenona, Somerset County, Maryland. Man Gut runs in a north/south direction behind the house and separates the high ground from the Deal Island Marsh. The house faces west with the principal gable oriented on an east/west axis.

Supported by a continuous brick foundation, the c.1837-38, gable front frame house is sheathed with aluminum siding and covered by a medium pitched asphalt shingle roof. Attached to the back of the main block is a two-story service wing.

The west (main) elevation is an asymmetrical elevation with an enclosed entrance in the north bay and two adjacent six-over-six sash windows. The entrance porch covers the original front door opening. A replacement front door is topped by a multi-pane transom. Lighting the second floor are three six-over-six sash windows. The gable front pediment is distinguished by a Palladian style, three-part window. The cornice is trimmed with mid nineteenth-century bed and crown moldings.

The north side of the main block has three six-over-six sash windows that light each floor, while the south side is marked by a recently built exterior brick chimney. Six-over-six sash windows are located to each side of the chimney. The chimney originally protruded through the roof along the back wall of the main block.

The two-story, two-bay service wing has been enlarged to the south by a shed roofed addition. Both floors are lighted by six-over-six sash windows. A partially glazed back door pierces the north wall of the kitchen.

The interior of the main block has been moderately remodeled with the relocation of the chimney and removal of the mid nineteenth-century mantel. The transverse hall retains the period stair which has a turned newel post, rectangular balusters, and an oval profile handrail. Following in the same fashion as other houses of the same period the stair passes directly over the windows in the southwest corner. Plain surrounds with plain corner blocks frame the door and window openings; however, the period doors have been stored away. The second floor was not seen on the initial visit.

Significance

The William Price house is a modest example of the Federal/Greek Revival style houses found throughout Somerset County. Dating from the mid nineteenth century, this transverse hall house is one of the oldest dwellings to remain standing in the Wenona vicinity. The Palladian window that pierces the gable front pediment is an unusual feature not shared by other houses of the same form. In spite of some remodeling, a large portion of the mid nineteenth-century woodwork has survived.



<p>This is a frame house, 3 bays wide, with a pedimented front. The door is very simple and is on the right. All of the windows are 6/6. The pediment window is tripartite -- the top section is a fan light with a hemisphere pattern. There is one enclosed chimney at the rear of the house.</p> <p>Until recently a 2 storey log slave house stood on the property but it has been torn down. The site of the first revenue office in Somerset County is on the property.</p> <p>Although the owner reputed this house to be the oldest occupied dwelling on Deal Island, the present architectural condition reveals it as a Federal house -- no earlier. The Deal Island Management Asso. House is older. It is possible that the original structure has been built into the present one and altered beyond recognition, or that this house is built on the foundations of the oldest house on Deal Island.</p> <p>This house is merely a country adaptation of the Federal style. Its only distinguishing feature is the 3-part Pulladian window in the pediment. It is also important because it is the only Federal type house standing on Deal Island.</p>


