Located on the west side of Freedomtown Road in the historic black community of Freemantown, this two-and-a-half story frame house is raised on a high concrete block pier foundation. Elevated well above surrounding structures, the weatherboard frame house dates from the early 1920s and is distinctive to that time with its squarish form, pyramidal roof, and single-pane sash windows. The high foundation elevated the structure from the low-lying, poorly drained nature of the lot and protected foundation timbers from decay.

Construction of this house is attributed to George H. Miles, who purchased the Freemantown lot in June 1923 for \$500. He financed the building program within the five years following, and George Miles is recorded in a mortgage of \$1560 to “The Home Building and Loan Association of Crisfield, Maryland, Inc.” in 1928.

The George H. Miles house stands on the west side of Freedomtown Road in the black community of Freemantown, Somerset County, Maryland. The two-and-a-half story frame dwelling faces east. It is abandoned and surrounded by a heavy growth of small trees, bushes and vines.

Dating from around 1920-25, the two-and-a-half story weatherboard frame house is supported by a high concrete block pier foundation, and the squarish main block is topped by a steeply pitched pyramidal roof. A layer of asphalt shingles covers an older layer of wood shingles. Attached to the back of the main block is a shed roofed addition.

The east (main) facade is a three-bay elevation with a partially enclosed shed roofed porch that covers the first floor. Paired single-pane sash windows light the first floor, and a series of three evenly spaced single-pane sash windows light the second floor. The base of the roof is finished with a boxed cornice. The east face of the pyramidal roof is marked by a hip roofed dormer that has a pair of single-pane windows. The glass is gone. Rising through the center of the house is an interior single-flue brick stove chimney.

The south side of the house is marked by an asymmetrical fenestration with paired single-pane sash windows lighting the first floor, and a single one-over-one sash window illuminating the second floor. The windows are framed by plain board surrounds.

The north side is similarly finished, and the west (rear) wall is enlarged by a hip roofed kitchen addition.

The interior was not seen.




