The Bozman house, located at 24892 Deal Island Rd., Dames Quarter, Somerset County, MD is not located in an historic district nor is it considered eligible for individual listing on the National Register of Historic Places.

The Bozman House is a 2-1/2 story center gable I-house built circa 1890-1920. The frame structure sits on a sticated concrete block base, and is covered with a low gable roof with 2 interior chimneys. There is one addition on the south side of the house. The porch, which retains its decorative trim has been partially enclosed and screened. The windows are two over two sash.

The dwelling is typical of the domestic architecture of the period and lacks the architectural distinctiveness to qualify for listing on the National Register of Historic Places under Criterion C. The property is not known to have any associations with persons or events significant to our past and is thus not eligible under Criteria B or A.
