The house at Long Lane Farm was extensively renovated within the last twenty years and then suffered a major fire in 1972.

The initial stage of the structure, of hall and parlor plan, was 1 1/2 stories in height with a jerkinhead roof and brick end walls laid in Flemish bond. The side walls were originally framed and brick-nogged and covered with beaded clapboards.

A single exterior chimney stood at each end.

Probably before
1800 the rear of the house was extended by an addition of two rooms. The north wall of this addition had an exterior chimney while the south wall continued out to form a small projecting closet with a shed roof. Also in Flemish bond, the brickwork of this section is of better quality than that in the main section.

In close proximity to the main house stand a brick, pyramid-roofed smokehouse (later remodeled as a dairy) and an extensively remodeled, detached frame kitchen.

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

THE HOUSE AT LOVE LANE FARM WAS EXTENSIVELY RENOVATED ON THE INTERIOR WITHIN THE LAST 5 YEARS. ON DECEMBER OF 1971 IT SUFFERED SEVERE DAMAGE BY FIRE.

ORIGINALLY THE HOUSE WAS OF HALL AND PARLOR PLAN, ONE STORY IN HEIGHT. IT WAS OF FRAME CONSTRUCTION WITH BRICK END WALLS. A SINGLE EXTERIOR CHIMNEY STOOD AT EACH END. THE CENTERED DOOR OF BOTH THE FRONT (E) AND REAR (W) ELEVATIONS WAS FLANKED BY A SINGLE (APPROX. 3' x 4 1/2') WINDOW TO EACH SIDE. BENEATH EACH WINDOW WAS A WOOD BARRED WINDOW TO LIGHT THE CELLAR. THE ROOF WAS "A" FRAME AND THE EAVES WERE BOVED. THIS PART OF THE HOUSE DATES CA. 1730-40.

ON THE LATE 18TH C. (4TH Q.) THE ROOF WAS EXTENDED DOWNWARD AT THE W. ELEVATION ALLOWING FOR 2 CELL ROOMS AT THE REAR. THE FENESTRATION + DOOR PLACEMENT OF THE 1ST ORIGINAL ELEVATION WAS REPEATED. A PECULIARITY OF THIS ALTERATION WAS THE EXTENSION OF THE SW CELL S. WALL TO FORM A PENT. AN EXTERIOR CHIMNEY WAS BUILT AT THE N WALL OF THIS W. ELEVATION EXTENSION.

IN CLOSE PROXIMITY TO THE MAIN BLOCK STANDS A BRICK SMOKEHOUSE AND WHAT WAS ONCE A KITCHEN, BOTH OF LATE 18TH OR EARLY 19TH C. DATE.





STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

All of the interior woodwork was destroyed during the 20th C. renovation, with the exception of a mantle which was used in the restoration of Sandgates, St. Marys Co. Interior woodwork included cornices and chair rails. The ceilings and walls were of painted plaster and the floors were of wood. The attic contained one (?) large, dormerless room. Int. + Ext. frame walls were brick nogged.

LONG LANE FARM

Before 1674

The house at the end of the long lane was originally of two rooms downstairs, with brick ends and clapboarded sides. It had arched fireplaces and a brick terrace in front.

The present porch and the two rooms at the rear are later, though old. In spite of romance the pent has no cellar-way or trap door and was not used in Indian attacks. The oldest brick walls are only nine inches thick.

"Long Lane" was built by Lt.-Col. John Jarboe of Dijon, who died in 1674. He was Lord High Sheriff of St. Mary's County. The house was later owned by the Carrolls.


