Located on Deep Creek, the deepest creek on St. Clements Bay, this five bay, two-and-a-half story structure is a substantial farmhouse finished with fine Italianate detailing. The Denton Farmhouse is significant as the location of Walter Benjamin Dent's medical office. Dr. Dent served the seventh district of St. Mary's County from the late nineteenth century through the early twentieth century. Unfortunately, the Denton Farmhouse has been unoccupied for many years and is currently in a very deteriorated condition.

According to Dr. Dent's grandchildren, the oldest section of the Denton Farmhouse is the library, located to the east of the center hall of the main block. This room was once a free-standing building around which the main block of the house was built. The east and west additions to the house were constructed at a later date.

The Denton Farmhouse is located at the end of Dent Road near Oakley in the Seventh District of St. Mary's County. The house faces south with the principle gable oriented on an east/west axis.

The Denton Farmhouse is composed of a central, five-bay, two-and-a-half story, ell-shaped main block flanked on the east and west elevations by one and one-and-a-half story additions. The house has been vacant for many years and is in very poor condition. All first floor windows and doors have been covered with plywood in order to keep vandals from entering the house. Many of the second floor windows retain their frames but no evidence of their original sash configurations. Most of these windows are now simply openings in the wall surface. The main block is sheathed with German siding and its roof is covered with wood shingles. The foundation is brick.

The south (main) elevation of the five-bay main block is pierced by a central door with two-light sidelights and a transom window. This entrance door is flanked by two windows on either side. A screened porch supported by square posts with decorative brackets stretches across the first floor of the main block. The roofline of the porch forms a small gable which is centered over the entrance door. The second floor is lit by four two-over-two sash windows and a central pair of one-over-one sash windows with narrow surrounds. At one time these windows were finished with louvered shutters. Only one pair of shutters survives. The roofline of the main block is marked by a central gable lit by two one-over-one sash windows crowned by a triangular pediment. At the peak of this gable is a turned wooden finial. The medium roof overhang is supported by plain brackets. The west end of the roof of the main block is pierced by an interior brick chimney. Attached to the west elevation is a one-story structure which once served as Dr. Dent's office. This wing has a hipped roof sheathed with wood shingles and supported by decorative brackets. One window and a door pierce the south side of this wing. Attached to the east end of the main block is an exterior brick chimney. Beyond this chimney stands a one-and-a-half story Italianate addition. The first floor of this addition is obscured by a one-story, parapet roof structure with a wide frieze band and decorative brackets which projects to the south. The addition was constructed for use as a nursery and was later used as a dining room. It is lit by a three-sided bay window and a single window. The upper half story of the one-and-a-half story structure behind the nursery is pierced by two dormers lit by six-over-six sash windows. An interior brick chimney pierces the roof of this wing. A shed roof porch supported by chamfered posts extends from the east side of this wing. The south end of the porch roof is decorated with jigsaw trim.

Located on Deep Creek, the deepest creek on St. Clements Bay, this five bay, two-and-a-half story structure is remarkable as a substantial farmhouse finished with fine Italianate detailing. This site is also significant as the location of Walter Benjamin Dent's medical office. Dr. Dent served the seventh district of St. Mary's County from the late nineteenth century through the early twentieth century. Unfortunately, the Denton Farmhouse has been unoccupied for many years and is currently in a very deteriorated condition.

According to Jane Linton, one of the current owners, the oldest section of the Denton Farmhouse is the library, located to the east of the center hall of the main block. This room was once a free-standing building around which the house complex was later built. The east and west additions to the house were built by Thomas Greenwell and by a Mr. Burlington. Mrs. Linton also recalls that the upper half story of the eastern kitchen addition, lit by two dormer windows, were the quarters for the Dent household's domestic servants.

According to Mrs. Linton, Walter Levi Dent, who is buried at All Saints Church in Oakley, financed the construction of this house. His son, Dr. Walter Benjamin Dent, was born here in 1859. As a teenager, Walter B. Dent took the steamboat from Stone's Wharf to the high school "St. John's College" in Alexandria. Later, he attended the University of Maryland Medical School. When he returned from Medical School, Dr. Dent constructed an office on the west side of the Denton farmhouse where he received patients.

Colin Burch, one of Dr. Dent's grandsons remembers that the Denton farmhouse originally had two kitchens. One for the main house and one for the field hands. These field hands raised tobacco, the primary crop produced on the Denton farm. Although the old field hand kitchen is gone, tobacco barns built in the 1940s and 1950s still stand on the property and continue to be used for curing tobacco today.

7.1 Description

The east elevation of the main block is pierced by one two-over-two sash window on the second floor and one six-over-six sash window at the attic level. The roof overhang of this elevation is supported by plain brackets. A two-story wing which forms the ell of the main block projects to the north. This wing is lit on the second floor by one shuttered two-over-two sash window. Projecting from the east side of the main block is the one-story nursery which is lit on the east elevation by two windows. Adjoining the nursery is the one-and-a-half story wing pierced by two window openings. The upper half story of this wing is lit by two four-pane windows. To the north of this wing projects a shed roof addition pierced by a door on the east side and a window on its south side.

The north elevation of the main block is pierced by two windows and one door with a transom on the first floor and three two-over-two sash windows with louvered shutters on the second floor. The first floor of this elevation is sheltered by a porch with square posts and decorative brackets. The eastern two bays of the main block are composed of the ell's gable end. This gable end is lit by two windows on the first floor, and two two-over-two sash windows on the second floor. The attic is lit by two one-over-one sash windows. To the east of the main block is a one-and-a-half story wing with a shed roof addition which is pierced on the first floor by a total of five windows. The one-story addition to the west of the main block is pierced by a window.

The west elevation of the main block is lit by one two-over-two sash window on the second floor. This gable end of the main block is supported by plain brackets. The one-story office which obscures the first floor of the main block is lit by one window. The west side of the ell is lit on the first floor by one window. The second floor is lit by one shuttered window opening.

The main block of the Denton Farmhouse consists of a center hall plan. Only the center hall interior of the house was seen by the surveyor. This wide center hall has an open stringer stair which rises to the second floor from the north elevation of the house. The stair has a turned newell post and turned balusters. There is a closet with a four-panel door under the stair. Four-panel doors survive on the interior of the house.

There are seven outbuildings on the property. Closest to the house stands a gable roof structure with a wood shingle roof and German siding sheathing. This building served as the smokehouse. A gable roof corn crib and an instrument shed also stand nearby. In addition, there are three tobacco barns, a concrete block stripping house, and a shed used for the storage of hay on the property.

NOTES: Transfer of "Part Canoe Neck" and "Part Oakley Farm" being on the left hand side of the Public Road leading from Oakley Post Office and store through Canoe Neck..." Being 90 acres more or less. Same as JYG 4/5. Price: \$2500

According to the Dent family, this property passed to Walter Benjamin Dent from his father Walter Levi Dent. There is no deed in the St. Mary's County Land Records which shows this transfer. There is also no will for Walter Levi Dent in the St. Mary's County Testamentary Records which may have shown this transfer. Since the deed references noted in MRB 167/390 do not show a transfer between Walter Levi Dent and Walter Benjamin Dent, and since it is unclear which parcel is occupied by the Denton Farmhouse, the chain of title will end here for now.

The following two deeds are the only references to Walter Levi Dent as grantee in the St. Mary's County Land Records. It may be that one of these refers to the Denton Farmhouse property, unless W. L. Dent inherited it.






