The Aloysius Bowling House is significant as a fine example of the Queen Anne architectural style in St. Mary's County. Although the exterior has been altered with the addition of artificial siding and brick veneer, its distinctive asymmetrical form and detailing remains intact. According to the current owner, this property was once known as "Oak Crest."

Aloysius Bowling operated a general merchandise business in Mechanicsville during the late nineteenth and early twentieth century. In 1898 he purchased 5 acres of the "Copsey Farm" from Zach and Nellie Morgan. At the time of his death in 1905, Bowling's real estate inventory listed his property as a "five acre farm with improvements...consisting of a house and outbuildings" (JTMR 1/178). Senator Horace Bowling later inherited this property.

The Aloysius Bowling House is located on the north side of the Mechanicsville-Chaplico Road in the village of Mechanicsville. The house stands on a slightly elevated site and is surrounded by cultivated fields. Three outbuildings stand on the north side of the house. The house faces south with the principal gable oriented on an east/west axis.

Constructed around 1898, the Bowling House is a fine example of the Queen Anne architectural style. This two-and-a-half story, frame structure is sheathed with vinyl siding and roofed with seamed metal. The house is supported by a continuous brick foundation.

The south (main) elevation of the house consists of an ell infilled with a three-story, octagonal tower which serves as the central entrance bay. A porch wraps around the tower bay to the west side of the house. The original porch supports have been replaced by metal Doric columns. The first floor of the tower is pierced by a partially glazed entrance door with a three-light transom and two-light sidelights. The first floor is also lit by two one-over-one sash windows. The second floor is lit by four two-over-two sash windows. The third floor is lit by three two-over-two sash windows crowned by a pediment infilled with decorative cut-out scroll work. The tower roof is sheathed with square butt shingles and capped by a decorative finial. To the east of the central tower is the two-and-a-half story, gable end of the ell. The first two floors of this wing consist of a projecting three-sided bay. This bay is lit on the first floor by three one-over-one sash windows and on the second floor by three two-over-one sash windows. The upper half story of the wing is sheathed with fish scale shingles and lit by one two-over-two sash window like that which lights the tower's third story.

The east elevation consists of a two-and-a-half story gable end wing with a two-story cut-away bay. The first floor consists of a projecting three-sided bay lit by one large two-over-two sash window on the east side and by two smaller one-over-one sash windows on the north and south sides. The second floor of this wing is lit by one two-over-two sash window. The upper half story is finished with cornice returns and lit by one two-over-two sash window. This gable end is supported by wood brackets in the area where the second floor bay has been cut-away. To the north of this wing extends a three-bay section of the house capped by a gable roof. The first floor of this portion of the house is pierced by a glazed entrance door and two pairs of louvered six-light windows. A porch, now enclosed with sliding glass doors, extends across the first floor. The second floor is lit by three two-over-two sash windows. Attached to the rear of the house is a two-story kitchen addition lit on the first floor by two small one-over-one sash windows. The second floor is lit by one six-over-six sash window and

The north elevation of the kitchen addition is blind except for a first floor door. A porch, enclosed with sliding glass doors and supported by a cinderblock foundation, extends across the first floor. The eave is finished with cornice returns and an interior brick chimney pierces the roof ridgeline. West of the kitchen extends the hipped roof center section of the house. This section was sheathed with brick veneer in 1990 and lit on the first floor with two pairs of compass-headed louvered windows. A hipped roof dormer projects from the roof of this wing, lit by one two-over-two sash window.

The west elevation of the kitchen wing is lit on the first floor by three one-over-one sash windows. The second floor is pierced by two six-over-six sash windows. The brick veneer, hipped roof section of the west elevation is pierced on the first floor by a modern glazed entrance door and two pairs of compass-headed louvered windows. The second floor is lit by two one-over-one sash windows. An interior brick chimney pierces the west roof slope. To the south of this central brick veneer section of the house is a two-and-a-half story gable end wing with a two-story, three-sided, cut-away bay. The first floor is lit by three one-over-one sash windows while the second floor is lit by two one-over-one and one two-over-two sash window. The upper half story is lit by one two-over-two sash window. This gable end is supported by wood brackets in the area where the second floor bay has been cut-away.

The interior of the house consists of 17 rooms, although the upper half story has never been finished. The interior retains many of its original finishes including molded door architraves with corner blocks, a decorative open stringer stair, and two slate mantels inlaid with marble. These mantels were said to be gifts to Senator Bowling from the ambassador from China.

Three outbuildings stand on the property. Directly south of the house stands a cinderblock garage roofed with seamed metal. Southwest of the house stands a frame granary roofed with corrugated metal and a gambrel roofed barn sheathed with plywood.


