1882

This small chapel was constructed during the late Victorian era in a board and batten Gothic Revival style. It was built for the use of the black parishioners of All Faith Parish and used by them for many years. In the 1950's the parish was re-integrated and St. Mary's was abandoned. In 1976 the church was demolished. The cemetery, used by black members of All Faith, has been restored and will be maintained.

Of ~~frame~~ construction and built in a Gothic Revival style, the St. Mary's Church has the distinction of being one of very few such churches in this area. A rectangular block measuring approximately 20'X50' the structure is one story in height with an "A" frame roof. The exterior is sheathed in vertically hung boards in Victorian barge board fashion. At the W. end, ^{stands} a slender bell tower with an open belfry and bell. The structure is four bays in length with a smaller contemporary wing () at the E. end.

The building is in an advanced state of deterioration and has been boarded up.
