Similar in plan to Nevitt's St. Anne, this house is a one-story frame structure with a steeply angled gable roof. At the east end stands a massive exterior chimney, almost a duplicate of that seen at Maxwell Hall in Charles County. The north facade is five bays in length with narrow windows framing sash of 4/4 panes, flush beaded weatherboarding, and a one-story farm porch of interesting construction, possibly contemporary to the house. A long, shed-roofed addition was recently built at the southwest corner.

Locust Hill

This is a most interesting structure that warrants further architectural and historical research. It will be especially valuable for comparative purposes.

Similar in plan to Nevitt's St. Anne (SM-198) the house is a one story frame block with an "A" frame roof. At the E. end stands a massive exterior chimney, almost a duplicate of those chimneys at Maxwell Hall (CH-196). The N. facade is five bays in length with narrow windows framing sash of 4/4 panes, has flush beaded weatherboarding, and a one story farm porch of most interesting construction that may or may not be contemporary to the main block. There is an elongated shed roofed addition of modern date at the SW corner.

The house appears to be in good physical condition but is not well cared for. It apparently is being used to store a mammoth accumulation of junk furniture and odd pieces of farm equipment.
