This two-story frame house was built in three stages. First was the east room and hall, a 1 1/2-story structure of hewn timbers. Second was the two-story west half of the building with circular sawn timbers. Later the first section was raised to two full stories, creating a house five bays on the first floor and six on the second with two cross gables. A kitchen ell and shed were added to the southeast, a porch to the southwest and a porch across the north. The three chimneys have been converted for use with stoves.

A converted smokehouse stands to the southeast of the house. Across the street is the Latham store, which was built by a former owner of this house (see S M -241).
