Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*
 Erstwhile, constructed in 1811, notes the adaptation of the inanimate to the surrounding activity. Once a two-story farmhouse with chimneys and dormers, the structure was converted to a tobacco barn during the 1940's. Documents in the Maryland Historic Trust Library note that a former owner had in their possession a brick from a removed chimney inscribed with the date "1811" and which had been located at the base of the chimney. The structure sits on a slight rise and while prominent in its immediate surroundings, is offset a distance from the main road and is partially obscured by a small stand of trees. The building sits in a distinctly agricultural context, and has its rustic utilitarian character enhanced by two additional dark, weathered farm structures of similar physical appearance and traits, anchoring either side of the fields located beside and in front of the converted farmhouse. The distinction between the original house and the additions on each side is mildly imperceptible considering the visible exterior materials and condition. An argument could be made that the resilience of the house seemingly constructed nearly 200 years ago is evident. The plan and form are simple, however modest might be a better description. The overall scale and the intricacy of the interior framing contribute to the architectural significance.



Erstwhile, built in 1811, was converted for use as a tobacco barn in the first part of the twentieth century. The house is little more than a shell today. The interior has been gutted and the original dormer windows have been removed from the north and south roof slopes. The house is flanked on the east and west by attached barn wings.

The name "Erstwhile" was assigned to the site when it was first surveyed by the Maryland Historical Trust in the 1970s. However, the source for the name is not documented and the name does not appear in archival records. The tract is described in the Land Records as the "Leo Hayden Farm," although it remains unclear how Hayden became possessed of the property. It seems highly likely that this parcel is the same as "Clarke's Purchase," Lot No. 5 of Beaverdam Manor, as illustrated on a plat in Benjamin Tippet's Surveyor Log Book A. Leo Hayden's wife may have inherited the 137 acre tract from her parents, John J. Mills and Catherine Clarke Mills, and brought the property to their marriage in 1864.

In 1935, the Leo Hayden Farm was sold to John W. Garner who sold it to Preston and Rosalie Insley three years later. The Insley family continued to own the property until 1966. Sometime in the 1930s or 1940s, the house was rented to Albert and Agnes Wood. The Wood family hosted weekend dances in the house and the property became known locally as "Bugaboo Bottom." During the Insley ownership the house was converted for use as a tobacco barn. Beginning in the late 1940s, the interior of the house was stripped, the dormer windows and west elevation chimney were removed, and barn wings were added to the east and west elevations. According to John L. Insley, a brick inscribed with the date "1811" was located at the base of the chimney at the west end of the house. This brick is now in his possession.

Contributing Resource Count: 2

Erstwhile is located in a valley at the end of an unpaved road on the north side of Hollywood - Leonardtown Road (Route 245) near Hollywood in St. Mary's County, Maryland. Open fields extend in front of the house and a stand of trees is located behind the house. Three twentieth-century outbuildings, including a granary and two sheds, stand next to the house. A nineteenth-century tobacco barn is located southeast of the dwelling near a second and more modern tobacco barn. The house, which has been altered for use as a tobacco barn, faces south with the principal gable oriented on an east/west axis.

Apparently built in 1811, the one-and-a-half story, frame structure was built on a slight rise in the landscape. The house measures 26' by 30' and is supported by a continuous brick foundation. The exterior is sheathed with weatherboard siding attached with wire and machine cut nails. The roof is covered with seamed metal.

The south (main) elevation is pierced by a four-panel door surmounted by a four-light transom window as the eastern bay. The door surround is narrow and finished with an interior bead. A metal box lock is mounted on the door. A portion of the original patent seal reading "Approved Lock" and illustrated with an eagle remains on the lock. Two six-over-six sash windows finished with an interior bead extend to the west of the door. The two dormer windows that originally pierced the south roof slope have been removed.

Both the east and west elevations are obscured by barn additions. Except for the most essential framing members, these gable end walls have been stripped. From the interior of the house the framing shows that small windows originally pierced the eaves of both elevations. According to a former owner, an exterior brick chimney originally stood against the west wall. No evidence of that chimney remains today.

The north elevation has also been reworked. Two dormers that originally pierced the north roof slope have been removed.

The interior of the house originally consisted of a side hall, double pile plan. The north parlor was considerably smaller than the south parlor, measuring 20' feet in length and only 10' in width. The south parlor measures 20' by 16' in width. Since the house was gutted in the 1940s, much of the original heavy timber framing remains visible. The original sills, down braces, studs and tie beams are hewn and pit sawn. The tie beams are whitewashed but have also been imbedded with nails on the underside of the beam suggesting that they were plastered at one point. Sawn lath remains attached to the first floor walls while riven lath is visible on the wall area of the

Erstwhile, built in 1811, was converted for use as a tobacco barn in the first part of the twentieth century. The house is little more than a shell today. The interior has been gutted and the original dormer windows have been removed from the roof slope. The house is now flanked on the east and west by attached barn wings.

The name "Erstwhile" was given to this property when it was first surveyed. However, the source for the name is not documented and the name does not appear in archival records. This property is described in the Land Records as the "Leo Hayden Farm." According to his obituary in the St. Mary's Enterprise dated September 10, 1898, Leo Havermans Hayden (1836-1898) was the son of Stephen Hayden and Maria Mills Hayden. He resided in St. Mary's County until 1880 when he was appointed tobacco inspector. In that year he moved to Baltimore with his family.

It remains unclear how Hayden became possessed of this property. In 1935, the Land Records show that his stepdaughter Catherine E. Lloyd inherited the farm from her mother, Mary E. Floyd Hayden, and two deceased sisters, Mary and Ann (Nannie) Floyd. There are, however, no testamentary records for these individuals in the St. Mary's County Courthouse. There are also no deeds to these individuals or to Leo Hayden which appear to describe the property. While it could be that Leo Hayden inherited the property from his father, Stephen Hayden, neither those deeds recorded to Stephen nor his will appear to describe the tract. It may be that Leo Hayden's wife inherited the property from her first husband, William Giles Floyd, or from her parents, John J. Mills and Catherine Clarke Mills, and brought this property to their marriage in 1864. There are no wills for Mary Hayden's first husband or for her parents. Of those deeds to her first husband only one for a 152 acre tract of Beaverdam and Fenwick Manor (JH13/359) seems a possible match.

According to a plat of Beaverdam Manor located in Benjamin Tippet's Surveyor Log Book A, the Hayden farm appears to be located on the site of Lot No. 5, "Clarke's Purchase." This plat was originally drawn up by George Fenwick in 1792 when the property was laid down into lots and sold off following its confiscation as British

property. Tippet transcribed the plat and its accompanying tract descriptions. Based on the known location of "Drury's Delight" and "Woodpecker," also illustrated on the plat, "Clarke's Purchase" seems to be a likely location for what is now known as the Hayden farm. In addition, the description for the tract notes that it begins "...at a cedar post in a bottom..." and contains 136 acres. The house site on the Hayden farm is located in a distinct valley, or bottom, and as late as 1935 the property is listed as 137 acres. It could be that "Clarke's Purchase" was inherited by Mary E. Floyd Hayden's mother, Catherine Clarke Mills. This property may have served as the home of Mary Hayden's parents or her grandparents.

In 1935, the Leo Hayden Farm was sold to John W. Garner who sold it to Preston and Rosalie Insley three years later. The Insley family continued to own the property until 1966. Sometime in 1930s or 1940s, the house was rented to Albert and Agnes Wood. The Wood family hosted weekend dances in the house and the property became known locally as "Bugaboo Bottom."

There are no testamentary records for Catherine E. Lloyd's sisters, Mary and Ann (Nannie) Floyd, in the St. Mary's County courthouse. There are also no records for her mother, Mary E. Floyd Hayden, in St. Mary's County. It seems likely that she died in Baltimore as did her husband Leo H. Hayden. Leo Hayden died in Baltimore in 1898 and there is no will recorded for him in St. Mary's County.

This one-story frame house lost its double chimney stack on the south gable when it was converted into a tobacco barn. Now the central section of the long barn, it originally had a side passage, double parlor plan.

Once a one story, frame house, which has now come to a curious end as the center section of a long tobacco barn. Original plan: side passage opening separately into one front and one back room, the E room being the larger by a foot or two. Each was heated by an exterior chimney stack on the S gable, both of which were dismantled when the building was converted. Upstairs, same plan, except that only the front chamber was provided with a hearth. Two dormers lit each chamber.

Well built frame shows none of the archaic features common to smaller and poorer backcountry houses. Interiors lathed and plastered.

Date based on mature, machine-made lathing nails used in primary contexts and on the style of all door and window trim: flat-faced architraves carrying three, deep, flat-bottomed grooves. No corner blocks.


