4th quarter 19th century

This large, two-story frame house with an A-roof is now abandoned and rapidly deteriorating, but when built in the last quarter of the 19th century, it was one of the largest and most substantial houses belonging to a black family in rural southern Maryland. The house was built in a T-plan. The principal block has a three-bay, balanced facade and is one room deep. It has two rooms on each floor and a central chimney. The rear wing is two bays long and also has two rooms downstairs and upstairs. According to oral tradition, this house was built by Joseph B. Herbert, a black landowning farmer. It is still owned by his descendants who live in a new ranch style house nearby.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large two-story frame house is now abandoned and is rapidly collapsing. Because of its dangerous condition, a full investigation of the interior was not possible. Since the stairs leading up into the chambers of the second floor had given way, no investigation of the upstairs was possible.

The house is designed in a T plan, with the length oriented toward the north serving as the principal facade. The principal roof line is oriented along a West-East axis, crossed in the east by the north-south block. The principal block is two bays in length and one bay in depth, while the perpendicular section is two bays long and one deep. The frame was originally clad in board and batten siding, which remains on the western gable end. Elsewhere, the siding was replaced by asbestos shingles. The cornices were boxed with plain boards, while the verge boards were scalloped. The roof was covered with wood shingles, which have been covered with tin. A front porch once extended along the facade of the principal block. All of these features are now in ruinous condition, giving the house a derelict appearance though it was once a handsome, proud structure.

In plan the principal block of the T design consisted of one room down and one up, with a spacious cross passageway bisecting the house on both floors. The perpendicular eastern block had two rooms down and two up, and there was once a one story kitchen that extended from the south wall of that block that has since been pulled down.

The frame skeleton is of massive hewn timbers morticed, tenoned, and pegged into place. Circular saw cut, 4" x 4" studs rise from the sill to the second story plate, in the fashion of the balloon frame design. Interestingly enough, they are not toed into place as was typical of the balloon frame, but were morticed and tenoned into the sills and plates. The construction of this house is, therefore, a blend of the old and new methods.

The walls were lathed and plastered inside. An inside gable end chimney brick chimney ascended the western block with the downstairs fireplace filled in to serve a wood stove. Through the middle of the eastern block ascended another brick chimney originally built to serve only wood stoves.

To the south of the house once stood several farm outbuildings, according to descendants of the original occupants. These have since been pulled down.

STATEMENT OF SIGNIFICANCE

This house was built by Joseph B. Herbert, a black landowner and farmer. According to his descendants, he was born in circa 1848 and may have been a free Negro during the antebellum era. It is not known by them when he built this house, though the mixture of the traditional and new methods of construction suggests a date of 1870's or 80's.

As part of this survey, a number of photographs of this prominent landowning family were copied. They are of Joseph Herbert, his wife, his son, Scanell Herbert, and his two daughters who joined the Oblate Sisters of Providence Order -- Sister Cecilia and Sister Columbus.

Also photographed were Herbert's grandson, Frank Herbert, granddaughter, Elizabeth Gertrude Medley, and her husband, Charles A. Medley, together with their children, Tyrone, Charlene, and a friend Odell. The result is that the original occupants of the house down through their great grandchildren today were recorded.


