DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story frame house stands on the summit of a hill facing north and looking out towards Delabrooke Rd. which is about 75 y ards in front of it. At one time this house was probably the only dwelling on the property, but today dwellings for Mr. Curtis' children have been built nearby, a common occurence on the properties of black landowners that have been surveyed.

The house consists of principal block of two stories with a one story, one room kitchen (with wood stove) attached to the east side of the rear length. The design of the facade is a common one, a door centrally located with two windows flanking it (See houses at Beachville, such as STMA-283). A shed screen porch has been added to front, the weatherboards covered with aluminum siding, and the wood shingles roof with tar paper: all the changes reflecting the modern fixtures of a contemporary folk house.

The interior plan of the principal block is laid out in a hall and chamber design with a boxed staircase ascending the south-eastern corner, and a brick stove chimney ascending the exterior western gable end. Behind the house are several outbuildings, now used primarily for storage, but reminiscent of the days when this was a working farm.

STATEMENT OF SIGNIFICANCE

This house is another example of the house form that was adopted by small landowning black families in the late 19th and early 20th centuries.

The owner/occupant has been a helpful oral informant, having been raised at Cremona, (STMA-93A) which is located nearby. He also led me to Abraham Medley's log house.

One of the advantages to the continuity of family ties is seen at Curtis' house. He is an elderly widower and lives alone, but since his children's families live close at hand, his grandchildren are often at his house to lend him a hand with the household activities and chores, plus provide the company that is needed, especially by the elderly who live alone.




